24 In the interest of a prompt and speedy settlement of this matter, consistent with the public
25 interest and the responsibilities of the Director of Consumer Affairs and the Bureau of
26 Automotive Repair the parties hereby agree to the following Stipulated Settlement and
27 Disciplinary Order which will be submitted to the Director for his approval and adoption as the
28 final disposition of the Accusation.

1 PARTIES

2 1. Sherry Mehl (Complainant) is the Chief of the Bureau of Automotive Repair. She
3 brought this action solely in her official capacity and is represented in this matter by Kamala D.
4 Harris, Attorney General of the State of California, by Ron Espinoza, Deputy Attorney General.

5 2. Adel S. Atallah and Adelinos Auto Clinic (Respondents) are represented in this
6 proceeding by attorney Michael B. Levin, Esq., whose address is: 3727 Camino del Rio South,
7 Suite 200, San Diego, CA 92108.

8 **Adelinos Auto Clinic; Adel S. Atallah, Owner**

9 3. In or about 2000, the Bureau of Automotive Repair issued Automotive Repair Dealer
10 Registration Number ARD 209927 to Adel S. Atallah, doing business as and owner of Adelinos
11 Auto Clinic. The registration was in full force and effect at all times relevant to the charges
12 brought in Accusation No. 79/11-17, and will expire on March 31, 2012, unless renewed.

13 4. On or about November 6, 2001, the Bureau of Automotive Repair issued Smog
14 Check, Test and Repair, Station License Number RC 209927 to Adel S. Atallah, doing business
15 as and owner of Adelinos Auto Clinic. The smog check station license was in full force and
16 effect at all times relevant to the charges brought in Accusation No. 79/11-17, and will expire on
17 March 31, 2012, unless renewed.

18 **Adel S. Atallah**

19 5. In or about 1997, the Bureau of Automotive Repair issued Advanced Emission
20 Specialist Technician License Number EA 136532 to Adel S. Atallah. The technician license was
21 in full force and effect at all times relevant to the charges brought in Accusation No. 79/11-17,
22 and will expire on August 31, 2011, unless renewed.

23 JURISDICTION

24 6. Accusation No. 79/11-17 was filed before the Director of Consumer Affairs
25 (Director), for the Bureau of Automotive Repair (Bureau), and is currently pending against
26 Respondents. The Accusation and all other statutorily required documents were properly served
27 on Respondents on September 15, 2010. Respondents timely filed their Notice of Defense
28

1 contesting the Accusation. A copy of Accusation No. 79/11-17 is attached as Exhibit A and
2 incorporated herein by reference.

3 7. Adel S. Atallah has been and is authorized to enter into this stipulated settlement on
4 behalf of Adelinos Auto Clinic.

5 ADVISEMENT AND WAIVERS

6 8. Adel S. Atallah has carefully read, fully discussed with counsel, and understands the
7 charges and allegations in Accusation No. 79/11-17. Adel S. Atallah has also carefully read, fully
8 discussed with counsel, and understands the effects of this Stipulated Settlement and Disciplinary
9 Order.

10 9. Respondents are fully aware of their legal rights in this matter, including the right to a
11 hearing on the charges and allegations in the Accusation; the right to confront and cross-examine
12 the witnesses against them; the right to present evidence and to testify on their own behalf; the
13 right to the issuance of subpoenas to compel the attendance of witnesses and the production of
14 documents; the right to reconsideration and court review of an adverse decision; and all other
15 rights accorded by the California Administrative Procedure Act and other applicable laws.

16 10. Respondents voluntarily, knowingly, and intelligently waive and give up each and
17 every right set forth above.

18 CULPABILITY

19 11. Respondents admit the truth of each and every charge and allegation in Accusation
20 No. 79/11-17.

21 12. Respondents agree that Automotive Repair Dealer Registration Number ARD
22 209927, Smog Check, Test and Repair, Station License Number RC 209927, and Advanced
23 Emission Specialist Technician License Number EA 136532 are subject to discipline, and they
24 agree to be bound by the Director's imposition of discipline and probationary terms as set forth in
25 the Disciplinary Order below.

1 **DISCIPLINARY ORDER**

2 IT IS HEREBY ORDERED that Automotive Repair Dealer Registration Number ARD
3 209927, Smog Check, Test and Repair, Station License Number RC 209927, and Advanced
4 Emission Specialist Technician License Number EA 136532 are revoked. However, the
5 revocations are stayed and Respondents are placed on probation for five (5) years on the
6 following terms and conditions.

7 1. **Actual Suspension.** Automotive Repair Dealer Registration Number ARD 209927,
8 Smog Check, Test and Repair, Station License Number RC 209927, and Advanced Emission
9 Specialist Technician License Number EA 136532 are concurrently suspended for fifteen (15)
10 consecutive days, starting on the effective date of the Decision and Order.

11 2. **Obey All Laws.** Respondents shall comply with all statutes, regulations and rules
12 governing automotive inspections, estimates and repairs.

13 3. **Post Sign.** Adel S. Atallah shall post a prominent sign, provided by the Bureau,
14 indicating the beginning and ending dates of the suspensions and indicating the reason(s) for the
15 suspensions. The sign shall be conspicuously displayed in a location open to and frequented by
16 customers and shall remain posted during the entire period of actual suspensions.

17 4. **Reporting.** Respondents or Respondents' authorized representative must report in
18 person or in writing as prescribed by the Bureau of Automotive Repair, on a schedule set by the
19 Bureau, but no more frequently than each quarter, on the methods used and success achieved in
20 maintaining compliance with the terms and conditions of probation.

21 5. **Report Financial Interest.** Within 30 days of the effective date of this action, Adel
22 S. Atallah shall report any financial interest which any partners, officers, or owners of
23 Respondents' facility (Adelinos Auto Clinic) may have in any other business required to be
24 registered pursuant to Section 9884.6 of the Business and Professions Code.

25 6. **Random Inspections.** Respondents shall provide Bureau representatives unrestricted
26 access to inspect all vehicles (including parts) undergoing repairs, up to and including the point of
27 completion.

28 ///

1 7. **Jurisdiction.** If an accusation or petition to revoke probation is filed against
2 Respondent(s) during the term of probation, the Director of Consumer Affairs shall have
3 continuing jurisdiction over this matter until the final decision on the accusation or petition, and
4 the period of probation shall be extended until such decision.

5 8. **Violation of Probation.** Should the Director of Consumer Affairs determine that
6 either or both Respondents have failed to comply with the terms and conditions of probation, the
7 Department may, after giving notice and opportunity to be heard, temporarily or permanently
8 invalidate their registrations or suspend or revoke their licenses.

9 9. **Restrictions.** During the period of probation, Respondents shall not perform any
10 form of smog inspection, or emission system diagnosis or repair, until Respondents have
11 purchased, installed, and maintained the diagnostic and repair equipment prescribed by BAR
12 necessary to properly perform such work, and BAR has been given 10 days notice of the
13 availability of the equipment for inspection by a BAR representative.

14 10. **Cost Recovery.** Respondents shall pay the Bureau a portion of its costs of
15 investigation and enforcement of this matter in the amount of \$4,563.80, paid as follows:
16 Respondents shall make minimum monthly payments to the Bureau of \$84.51 per month,
17 beginning the month of the effective date of the Decision and Order. Payment in full to the
18 Bureau of the \$4,563.80 shall be received no later than 6 months before probation terminates.
19 All payments shall be in the form of a certified check, cashier's check or money order, payable to
20 the Bureau of Automotive Repair, and shall be mailed or delivered to the Bureau of Automotive
21 Repair, 10240 Systems Parkway, Sacramento, California, 95827, Attention: Enforcement
22 Planning & Oversight. Failure to complete payment of cost recovery within this time frame shall
23 constitute a violation of probation which may subject the registrations and licenses of
24 Respondents to outright revocation; however, the Director or the Director's Bureau of
25 Automotive Repair designee may elect to continue probation until such time as reimbursement of
26 the entire cost recovery amount has been made to the Bureau.

24 **PARTIES**

25 1. Sherry Mehl ("Complainant") brings this Accusation solely in her official capacity as
26 the Chief of the Bureau of Automotive Repair ("Bureau"), Department of Consumer Affairs.

27 ///

1 **Adelinos Auto Clinic; Adel S. Atallah, Owner**

2 2. In or about 2000, the Director of Consumer Affairs ("Director") issued Automotive
3 Repair Dealer Registration Number ARD 209927 (hereinafter "registration") to Adel S. Atallah
4 ("Respondent"), owner of Adelinos Auto Clinic. Respondent's registration was in full force and
5 effect at all times relevant to the charges brought herein and will expire on March 31, 2011,
6 unless renewed.

7 3. On or about November 6, 2001, the Director issued Smog Check, Test and Repair,
8 Station License Number RC 209927 (hereinafter "smog check station license") to Respondent.
9 Respondent's smog check station license was in full force and effect at all times relevant to the
10 charges brought herein and will expire on March 31, 2011, unless renewed.

11 **Adel S. Atallah**

12 4. In or about 1997, the Director issued Advanced Emission Specialist Technician
13 License Number EA 136532 (hereinafter "technician license") to Respondent. Respondent's
14 technician license was in full force and effect at all times relevant to the charges brought herein
15 and will expire on August 31, 2011, unless renewed.

16 **JURISDICTION**

17 5. Business and Professions Code ("Bus. & Prof. Code") section 9884.7 provides that
18 the Director may revoke an automotive repair dealer registration.

19 6. Bus. & Prof. Code section 9884.13 provides, in pertinent part, that the expiration of a
20 valid registration shall not deprive the Director of jurisdiction to proceed with a disciplinary
21 proceeding against an automotive repair dealer or to render a decision temporarily or permanently
22 invalidating (revoking or suspending) a registration.

23 7. Health and Safety Code ("Health & Saf. Code") section 44002 provides, in pertinent
24 part, that the Director has all the powers and authority granted under the Automotive Repair Act
25 for enforcing the Motor Vehicle Inspection Program.

26 8. Health & Saf. Code section 44072.6 provides, in pertinent part, that the expiration or
27 suspension of a license by operation of law, or by order or decision of the Director of Consumer

28 ///

1 Affairs. or a court of law, or the voluntary surrender of the license shall not deprive the Director
2 of jurisdiction to proceed with disciplinary action.

3 **STATUTORY PROVISIONS**

4 9. Bus. & Prof. Code section 9884.7 states, in pertinent part:

5 (a) The director, where the automotive repair dealer cannot show there
6 was a bona fide error, may deny, suspend, revoke, or place on probation the
7 registration of an automotive repair dealer for any of the following acts or omissions
8 related to the conduct of the business of the automotive repair dealer, which are done
9 by the automotive repair dealer or any automotive technician, employee, partner,
10 officer, or member of the automotive repair dealer.

11 (1) Making or authorizing in any manner or by any means whatever any
12 statement written or oral which is untrue or misleading, and which is known, or which
13 by the exercise of reasonable care should be known, to be untrue or misleading.

14

15 (4) Any other conduct that constitutes fraud.

16

17 (c) Notwithstanding subdivision (b), the director may suspend, revoke, or
18 place on probation the registration for all places of business operated in this state by
19 an automotive repair dealer upon a finding that the automotive repair dealer has, or is,
20 engaged in a course of repeated and willful violations of this chapter, or regulations
21 adopted pursuant to it.

22 10. Bus. & Prof. Code section 477 provides, in pertinent part, that "Board" includes
23 "bureau," "commission," "committee," "department," "division," "examining committee,"
24 "program," and "agency." "License" includes certificate, registration or other means to engage
25 in a business or profession regulated by the Bus. & Prof. Code.

26 11. Health & Saf. Code section 44072.2 states, in pertinent part:

27 The director may suspend, revoke, or take other disciplinary action
28 against a license as provided in this article if the licensee, or any partner, officer, or
director thereof, does any of the following:

(a) Violates any section of this chapter [the Motor Vehicle Inspection
Program (Health and Saf. Code § 44000, et seq.)] and the regulations adopted
pursuant to it, which related to the licensed activities.

. . . .

(c) Violates any of the regulations adopted by the director pursuant to
this chapter.

1 (d) Commits any act involving dishonesty, fraud, or deceit whereby
another is injured . . .

2 12. Health & Saf. Code section 44072.8 states that when a license has been revoked or
3 suspended following a hearing under this article, any additional license issued under this chapter
4 in the name of the licensee may be likewise revoked or suspended by the director.

5 **COST RECOVERY**

6 13. Bus. & Prof. Code section 125.3 provides, in pertinent part, that a Board may request
7 the administrative law judge to direct a licensee found to have committed a violation or
8 violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation
9 and enforcement of the case.

10 **VID DATA REVIEW**

11 14. On or about April 12, 2010, the Bureau initiated an investigation against Respondent
12 based on a review of information from the Bureau's Vehicle Information Database ("VID"),
13 which indicated that Respondent may be engaging in fraudulent smog check activities.

14 15. On or about April 14, 2010, a representative of the Bureau conducted a detailed
15 review of VID data for all smog inspections performed at Respondent's facility for the period of
16 January 1, 2009, through April 13, 2010. The representative found that the 11 vehicles identified
17 below, all of which were tested by Respondent, recorded certain diagnostic trouble codes
18 (hereinafter "code") during the OBD II tests¹. The representative obtained information indicating
19 that the codes were not applicable to the vehicles. The Bureau concluded that Respondent
20 performed the smog inspections on the vehicles using a different vehicle(s) during the OBD II

24 ¹ The On Board Diagnostics (OBD II) functional test is an automated function of the
25 BAR-97 analyzer. During the OBD II functional test, the technician is required to connect an
26 interface cable from the BAR-97 analyzer to a Diagnostic Link Connector (DLC) which is
27 located inside the vehicle. Through the DLC, the BAR-97 analyzer automatically retrieves
28 information from the vehicle's on-board computer about the status of the readiness indicators,
trouble codes, and the MIL (malfunction indicator light). If the vehicle fails the OBD II
functional test, it will fail the overall inspection.

1 tests, a method known as "clean plugging",² resulting in the issuance of fraudulent certificates of
2 compliance for the vehicles.

18 **FIRST CAUSE FOR DISCIPLINE**

19 **(Untrue or Misleading Statements)**

20 16. Respondent's registration is subject to disciplinary action pursuant to Bus. & Prof.
21 Code section 9884.7, subdivision (a)(1), in that Respondent made or authorized statements which
22 he knew or in the exercise of reasonable care should have known to be untrue or misleading, as
23 follows: Respondent certified that vehicles 1 through 11, identified in paragraph 15 above, had
24 passed inspection and were in compliance with applicable laws and regulations. In fact,

25 ² Clean-plugging is the use of the OBD II readiness monitor status and stored fault code
26 (trouble code) status of a passing vehicle for the purpose of illegally issuing a smog certificate to
27 another vehicle that is not in compliance due to a failure to complete the minimum number of self
28 tests, known as monitors, or due to the presence of a stored fault code that indicates an emission
control system or component failure.

1 Respondent conducted the inspections on the vehicles using clean-plugging methods in that he
2 substituted or used a different vehicle(s) during the OBD II functional tests in order to issue smog
3 certificates of compliance for the vehicles, and did not test or inspect the vehicles as required by
4 Health & Saf. Code section 44012.

5 **SECOND CAUSE FOR DISCIPLINE**

6 **(Fraud)**

7 17. Respondent's registration is subject to disciplinary action pursuant to Bus. & Prof.
8 Code section 9884.7, subdivision (a)(4), in that Respondent committed acts that constitute fraud
9 by issuing electronic smog certificates of compliance for vehicles 1 through 11, identified in
10 paragraph 15 above, without performing bona fide inspections of the emission control devices
11 and systems on the vehicles, thereby depriving the People of the State of California of the
12 protection afforded by the Motor Vehicle Inspection Program.

13 **THIRD CAUSE FOR DISCIPLINE**

14 **(Violations of the Motor Vehicle Inspection Program)**

15 18. Respondent's smog check station license is subject to disciplinary action pursuant to
16 Health & Saf. Code section 44072.2, subdivision (a), in that Respondent failed to comply with the
17 following sections of that Code:

18 a. **Section 44012:** Respondent failed to perform the emission control tests on vehicles 1
19 through 11, identified in paragraph 15 above, in accordance with procedures prescribed by the
20 department.

21 b. **Section 44015:** Respondent issued electronic smog certificates of compliance for
22 vehicles 1 through 11, identified in paragraph 15 above, without ensuring that the vehicles were
23 properly tested and inspected to determine if they were in compliance with Health & Saf. Code
24 section 44012.

1 **FOURTH CAUSE FOR DISCIPLINE**

2 **(Failure to Comply with Regulations Pursuant**
3 **to the Motor Vehicle Inspection Program)**

4 19. Respondent's smog check station license is subject to disciplinary action pursuant to
5 Health & Saf. Code section 44072.2, subdivision (c), in that Respondent failed to comply with
6 provisions of California Code of Regulations, title 16, as follows:

7 a. **Section 3340.24, subdivision (c):** Respondent falsely or fraudulently issued
8 electronic smog certificates of compliance for vehicles 1 through 11, identified in paragraph 15
9 above.

10 b. **Section 3340.35, subdivision (c):** Respondent issued electronic smog certificates of
11 compliance for vehicles 1 through 11, identified in paragraph 15 above, even though the vehicles
12 had not been inspected in accordance with section 3340.42.

13 c. **Section 3340.42:** Respondent failed to conduct the required smog tests on vehicles 1
14 through 11, identified in paragraph 15 above, in accordance with the Bureau's specifications.

15 **FIFTH CAUSE FOR DISCIPLINE**

16 **(Dishonesty, Fraud or Deceit)**

17 20. Respondent's smog check station license is subject to disciplinary action pursuant to
18 Health & Saf. Code section 44072.2, subdivision (d), in that Respondent committed dishonest,
19 fraudulent or deceitful acts whereby another is injured by issuing electronic smog certificates of
20 compliance for vehicles 1 through 11, identified in paragraph 15 above, without performing bona
21 fide inspections of the emission control devices and systems on the vehicles, thereby depriving
22 the People of the State of California of the protection afforded by the Motor Vehicle Inspection
23 Program.

24 **SIXTH CAUSE FOR DISCIPLINE**

25 **(Violations of the Motor Vehicle Inspection Program)**

26 21. Respondent's technician license is subject to disciplinary action pursuant to Health &
27 Saf. Code section 44072.2, subdivision (a), in that Respondent failed to comply with section
28 44012 of that Code, in a material respect, as follows: Respondent failed to perform the emission

1 control tests on vehicles 1 through 11, identified in paragraph 15 above, in accordance with
2 procedures prescribed by the department.

3 **SEVENTH CAUSE FOR DISCIPLINE**

4 **(Failure to Comply with Regulations Pursuant**
5 **to the Motor Vehicle Inspection Program)**

6 22. Respondent's technician license is subject to disciplinary action pursuant to Health &
7 Saf. Code section 44072.2, subdivision (c), in that Respondent failed to comply with provisions
8 of California Code of Regulations, title 16, as follows:

9 a. **Section 3340.24, subdivision (c):** Respondent falsely or fraudulently issued
10 electronic smog certificates of compliance for vehicles 1 through 11, identified in paragraph 15
11 above.

12 b. **Section 3340.30, subdivision (a):** Respondent failed to inspect and test vehicles 1
13 through 11, identified in paragraph 15 above, in accordance with Health & Saf. Code sections
14 44012 and 44035, and California Code of Regulations, title 16, section 3340.42.

15 c. **Section 3340.42:** Respondent failed to conduct the required smog tests on vehicles 1
16 through 11, identified in paragraph 15 above, in accordance with the Bureau's specifications.

17 **EIGHTH CAUSE FOR DISCIPLINE**

18 **(Dishonesty, Fraud or Deceit)**

19 23. Respondent's technician license is subject to disciplinary action pursuant to Health &
20 Saf. Code section 44072.2, subdivision (d), in that Respondent committed dishonest, fraudulent,
21 or deceitful acts whereby another is injured by issuing electronic smog certificates of compliance
22 for vehicles 1 through 11, identified in paragraph 15 above, without performing bona fide
23 inspections of the emission control devices and systems on the vehicles, thereby depriving the
24 People of the State of California of the protection afforded by the Motor Vehicle Inspection
25 Program.

1 OTHER MATTERS

2 24. Pursuant to Bus. & Prof. Code section 9884.7, subdivision (c), the Director may
3 suspend, revoke, or place on probation the registration for all places of business operated in this
4 state by Respondent Adel S. Atallah, owner of Adelinos Auto Clinic, upon a finding that
5 Respondent has, or is, engaged in a course of repeated and willful violations of the laws and
6 regulations pertaining to an automotive repair dealer.

7 25. Pursuant to Health & Saf. Code section 44072.8, if Smog Check, Test and Repair,
8 Station License Number RC 209927, issued to Adel S. Atallah, owner of Adelinos Auto Clinic, is
9 revoked or suspended, any additional license issued under this chapter in the name of said
10 licensee may be likewise revoked or suspended by the director.

11 26. Pursuant to Health & Saf. Code section 44072.8, if Advanced Emission Specialist
12 Technician License Number EA 136532, issued to Adel S. Atallah, is revoked or suspended, any
13 additional license issued under this chapter in the name of said licensee may be likewise revoked
14 or suspended by the director.

15 PRAYER

16 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
17 and that following the hearing, the Director of Consumer Affairs issue a decision:

18 1. Revoking or suspending Automotive Repair Dealer Registration Number
19 ARD 209927, issued to Adel S. Atallah, owner of Adelinos Auto Clinic;

20 2. Revoking or suspending any other automotive repair dealer registration issued to
21 Adel S. Atallah;

22 3. Revoking or suspending Smog Check, Test and Repair, Station License Number
23 RC 209927, issued to Adel S. Atallah, owner of Adelinos Auto Clinic;

24 4. Revoking or suspending Advanced Emission Specialist Technician License Number
25 EA 136532, issued to Adel S. Atallah;

26 5. Revoking or suspending any additional license issued under Chapter 5 of the Health
27 and Safety Code in the name of Adel S. Atallah;


