18 Complainant alleges:

19 **PARTIES/LICENSE INFORMATION**

20 1. Sherry Mehl ("Complainant") brings this Accusation and Petition to Revoke
21 Probation solely in her official capacity as the Chief of the Bureau of Automotive Repair
22 ("Bureau"), Department of Consumer Affairs.

23 2. On or about May 19, 2010, the Director of Consumer Affairs ("Director") issued
24 Advanced Emission Specialist Technician License Number EA 036716 ("technician license") to
25 Jaswinder Singh Nagra ("Respondent"). Respondent's technician license was immediately
26 revoked, the revocation was stayed, and Respondent was placed on probation for two years, as set
27 forth in paragraph 5 below. Respondent's technician license will expire on August 31, 2012,
28 unless renewed.

1 OTHER MATTERS


2 19. Pursuant to Health & Saf. Code section 44072.8, if Advanced Emission Specialist
3 Technician License Number EA 036716, issued to Respondent Jaswinder Singh Nagra, is
4 revoked or suspended, any additional license issued under this chapter in the name of said
5 licensee may be likewise revoked or suspended by the Director.

6 PRAYER

7 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
8 and that following the hearing, the Director of Consumer Affairs issue a decision:

- 9 1. Revoking probation and reimposing the order of revocation of Advanced Emission
10 Specialist Technician License Number EA 036716, issued to Jaswinder Singh Nagra;
- 11 2. Revoking or suspending Advanced Emission Specialist Technician License Number
12 EA 036716, issued to Jaswinder Singh Nagra;
- 13 3. Revoking or suspending any additional license issued under Chapter 5 of the Health
14 and Safety Code in the name of Jaswinder Singh Nagra;
- 15 4. Ordering Jaswinder Singh Nagra to pay the Director of Consumer Affairs the
16 reasonable costs of the investigation and enforcement of this case, pursuant to Business and
17 Professions Code section 125.3;
- 18 5. Taking such other and further action as deemed necessary and proper.
