c. Respondent Kahil's smog check inspector license is subject to discipline pursuant to	
Health and Safety Code section 44072.2, subdivision (d), in conjunction with Health and Safety	
Code section 44072.10, subdivision (c), in that Respondent Kahil committed acts involving	
dishonesty, fraud or deceit whereby another was injured by issuing electronic certificates of	
compliance for multiple vehicles without performing bona fide inspections of the emission	
control devices and systems on the vehicles, thereby depriving the People of the State of	
California of the protection afforded by the Motor Vehicle Inspection Program.	
<u>ORDER</u>	
IT IS SO ORDERED that Smog Check Inspector License Number EO 141408, issued to	
Respondent Mahmoud M. Kahil, is revoked.	
Pursuant to Government Code section 11520, subdivision (c), Respondent Kahil may serve	
a written motion requesting that the Decision be vacated and stating the grounds relied on within	
seven (7) days after service of the Decision on Respondent Kahil. The motion should be sent to	
the Bureau of Automotive Repair, ATTN: Patrick Lutfi, 10949 North Mather Boulevard, Rancho	
Cordova, CA 95670. The agency in its discretion may vacate the Decision and grant a hearing on	
a showing of good cause, as defined in the statute.
