9	PARTIES
10	1. Patrick Dorais (Complainant) brings this Accusation solely in his official capacity as
11	the Chief of the Bureau of Automotive Repair (Bureau), Department of Consumer Affairs.
12	2. On or about July 22, 2012, the Bureau issued Automotive Repair Dealer Registration
13	Number ARD 269642 to Mitchel Scott Bornstein - President/Secretary/Treasurer, Reid Ventures
14	d.b.a. Berkeley Smog Test Only Center (Respondent Shop). The Automotive Repair Dealer
15	Registration was in full force and effect at all times relevant to the charges brought herein and
16	will expire on July 31, 2018, unless renewed.
17	3. On or about July 19, 2012, the Bureau issued Smog Check, Test Only, Station
18	License Number TC 269642 to Respondent Shop. The Smog Check, Test Only, Station License
19	was in full force and effect at all times relevant to the charges brought herein and will expire on
20	July 31, 2018, unless renewed.
21	4. On or about April 16, 2009, the Bureau issued Advanced Emission Specialist
22	Technician License No. 630955 to Jessie Lewis Kent (Respondent Kent). Effective February 28,
23	2013, pursuant to Respondent Kent's election, said license was renewed as Smog Check Inspector
24	License No. EO 630955 and Smog Check Repair Technician License No. EI 630955. ¹ The Smog
25	Check Repair Technician License expired on February 28, 2015, and has not been renewed. The

1	Smog Check Inspector License was in full force and effect at all times relevant to the charges
2	brought herein and will expire on February 28, 2019, unless renewed.

4	150861 to Damien Francis Rochells (Respondent Rochells). Effective August 31, 2012, pursuant
5	to Respondent Rochells's election, said license was renewed as Smog Check Inspector License
6	No. EO 150861 and Smog Check Repair Technician License No. EI 150861. The Smog Check
7	Inspector License and Smog Check Repair Technician License were in full force and effect at all
8	times relevant to the charges herein and will expire on August 31, 2018, unless renewed.
9	JURISDICTION
10	6. This Accusation is brought before the Director of the Department of Consumer
11	Affairs (Director) for the Bureau under the authority of the following laws.
12	7. Section 9884.13 of the Business and Professions Code (Code) provides, in pertinent
13	part, that the expiration of a valid registration shall not deprive the Director or Bureau Chief of
14	jurisdiction to proceed with a disciplinary proceeding against an automotive repair dealer or to
15	render a decision invalidating a registration temporarily or permanently.
16	8. Section 44072.6 of the Health and Safety Code provides, in pertinent part, that the
17	expiration or suspension of a license by operation of law, or by order or decision of the Director,
18	or a court of law, or the voluntary surrender of the license, shall not deprive the Director of
19	jurisdiction to proceed with disciplinary action.
20	9. Section 44002 of the Health and Safety Code provides, in pertinent part, that the
21	Director has all the powers and authority granted under the Automotive Repair Act for enforcing


1	<u>COSTS</u>
2	18. Section 125.3 of the Code provides, in pertinent part, that the Bureau may request the
3	administrative law judge to direct a licentiate found to have committed a violation or violations of
4	the licensing act to pay a sum not to exceed the reasonable costs of the investigation and
5	enforcement of the case, with failure of the licentiate to comply subjecting the license to not being
6	renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be
7	included in a stipulated settlement.
8	FACTUAL BACKGROUND
9	19. On March 9, 2015, the Bureau implemented a statewide regulatory change requiring
10	the use of the On Board Diagnostic Inspection System (BAR-OIS) instead of the Emission
11	Inspection System (EIS) for the smog testing of 2000 model year and newer gas powered and
12	hybrid vehicles.
13	20. The new BAR-OIS smog inspection utilizes a Data Acquisition Device (DAD), a
14	computer, a bar code scanner, and printer. The DAD is a scan tool that retrieves data from a
15	vehicle's On Board Diagnostic-generation II (OBD II) computer. The DAD connects the BAR-
16	OIS computer to the vehicle's diagnostic link connector (DLC) to retrieve the data from the
17	vehicle. The bar code scanner is used to input technician information, the vehicle identification
18	number (VIN), and DMV renewal information. The printer is used to print Vehicle Inspection
19	Reports.
20	21. Data retrieved and recorded during an BAR-OIS smog check can include: the eVIN,
21	which is the digitally stored VIN programmed into the vehicle's Powertrain Control Module
22	(PCM); the communication protocol, which is the manufacturer/vehicle's specific "language" that
23	the PCM uses to relay information; and the number of Parameter Identifications (PIDs), which is
24	the number of specific data values that vehicle's PCM provides related to emission controls.
25	22. As part of BAR-OIS smog inspections, the technician also performs a visual and
26	functional test on the vehicle. The BAR-OIS software makes the determination whether or not the
27	vehicle passes the inspection based on the results of the data and the visual and functional tests.
28	If the vehicle passes the inspection, a certificate of compliance is issued. The information from

the smog inspection is then transmitted to the Vehicle Information Data (VID). The technician 1 affirms a statement for each inspection that the inspection performed complied with all applicable 2 laws and regulations. 3 The Bureau can access the VID to view test data on smog check inspections 4 23. 5 performed at any Smog Check station. The Bureau can also search for, retrieve, and print the test record for any particular vehicle which has been tested. 6 24. The Bureau has become aware of several methods used by Smog Check stations and 7 Smog Check technicians to issue improper/fraudulent smog certificates of compliance. One 8 9 method is known as clean plugging. Clean plugging involves using another vehicle's properly functioning OBD II system, or another source, to generate passing diagnostic readings for a 10 11 vehicle that is not in smog compliance or not even present for testing. 25. The Bureau initiated an investigation of Respondents. Between April 2015 and 12 January 2017, Respondent Shop, Respondent Kent, and Respondent Rochells were found to have 13 14 performed eight fraudulent smog inspections using clean-plugging methods. 15 26. A Bureau representative reviewed data for the eight vehicles at issue. The data revealed that the eight vehicles purportedly tested by Respondent Shop, Respondent Kent, and 16 Respondent Rochells were not and could not have been connected to the DAD when they were 17 being certified because the OBD-II data purportedly transmitted by those vehicles could not have 18 19 been transmitted by those vehicles. 20 27.
