**FINDINGS OF FACT**

1  
2           1.     On or about September 17, 2013, Complainant Patrick Dorais, in his official capacity  
3 as the Acting Chief of the Bureau of Automotive Repair, Department of Consumer Affairs, filed  
4 First Amended Accusation No. 79/12-75 against Smog Stop Test Only, Abe I. Rabadi, Owner and  
5 Abe I Rabadi, Technician (Respondent) before the Director of Consumer Affairs. (First  
6 Amended Accusation attached as Exhibit A.)

7           2.     On or about September 18, 2013, Respondent was served by Certified and First Class  
8 Mail copies of the First Amended Accusation No. 79/12-75 and Supplemental Statement to  
9 Respondent's addresses of record which, pursuant to Business and Professions Code section 136,  
10 are required to be reported and maintained with the Bureau. Respondent's addresses of record  
11 were and are: 3186 Madison Street, Riverside, CA 92505 and P.O. Box 70435, Riverside, CA  
12 92513.

13           3.     On or about September 25, 2009, the Director of Consumer Affairs (Director) issued  
14 Automotive Repair Dealer Registration Number ARD 259545 to Abe I. Rabadi (Respondent  
15 Rabadi), owner of Smog Stop Test Only. On February 6, 2012, Respondent's registration was  
16 revoked; however, the revocation was stayed and Respondent was placed on probation for three  
17 (3) years on terms and conditions. The Automotive Repair Dealer License was in full force and  
18 effect at all times relevant to the charges brought in First Amended Accusation No. 79/12-75.  
19 Respondent's registration expired on September 30, 2012, and has not been renewed. This lapse  
20 in licensure, however, pursuant to Business and Professions Code section 9884.13, does not  
21 deprive the Director of her authority to institute or continue this disciplinary proceeding.

22           4.     On or about October 23, 2009, the Director issued Smog Check, Test Only, Station  
23 License Number TC 259545 to Respondent Rabadi. On February 6, 2012, Respondent's smog  
24 check station license was revoked; however, the revocation was stayed and Respondent was  
25 placed on probation for three (3) years on terms and conditions. The Smog Check, Test Only,  
26 Station License was in full force and effect at all times relevant to the charges brought in First  
27 Amended Accusation No. 79/12-75. Respondent's smog check station license expired on  
28 September 30, 2012, and has not been renewed. This lapse in licensure, however, pursuant to

1 Business and Professions Code section 9884.13, does not deprive the Director of her authority to  
2 institute or continue this disciplinary proceeding.

3 5. On or about July 15, 2009, the Director issued Advanced Emission Specialist License  
4 Number EA 631177 to Respondent Rabadi. Respondent's advanced emission specialist  
5 technician license was due to expire on April 30, 2013. Pursuant to California Code of  
6 Regulations, title 16, section 3340.28, subdivision(e), the license was renewed, pursuant to  
7 Respondent's election, as Smog Check Inspector License No. EO 631177, effective May 3, 2013.  
8 Respondent's smog check inspector license will expire on April 30, 2015, unless renewed.

9 6. On or about February 3, 2012, Complainant Sherry Mehl, in her official capacity as  
10 the Chief of the Bureau of Automotive Repair, Department of Consumer Affairs, filed Accusation  
11 No. 79/12-75 against Smog Stop Test Only, Abe I. Rabadi, Owner and Abe I Rabadi, Technician  
12 (Respondent) before the Director of Consumer Affairs.

13 7. On or about February 21, 2012, Respondent was served by Certified and First Class  
14 Mail copies of the Accusation No. 79/12-75, Statement to Respondent, Notice of Defense,  
15 Request for Discovery, and Discovery Statutes (Government Code sections 11507.5, 11507.6,  
16 and 11507.7) at Respondent's address of record which, pursuant to Business and Professions  
17 Code section 136, is required to be reported and maintained with the Bureau. Respondent's  
18 address of record was and is: 3186 Madison Street, Riverside, CA 92505.

19 8. Service of the First Amended Accusation was effective as a matter of law under the  
20 provisions of Government Code section 11505, subdivision (c) and/or Business & Professions  
21 Code section 124.

22 9. On or about February 29, 2012, Respondent, through counsel, signed and returned a  
23 Notice of Defense, requesting a hearing in this matter. A Notice of Hearing was served by mail at  
24 Respondent's addresses of record and upon his attorney and it informed them that an  
25 administrative hearing in this matter was scheduled for September 25, 2013. Respondent and his  
26 attorney failed to appear at that hearing.

27 ///

28 ///

1 10. Government Code section 11506 states, in pertinent part:

2 (c) The respondent shall be entitled to a hearing on the merits if the respondent  
3 files a notice of defense, and the notice shall be deemed a specific denial of all parts  
4 of the accusation not expressly admitted. Failure to file a notice of defense shall  
5 constitute a waiver of respondent's right to a hearing, but the agency in its discretion  
6 may nevertheless grant a hearing.

7 11. California Government Code section 11520 states, in pertinent part:

8 (a) If the respondent either fails to file a notice of defense or to appear at the  
9 hearing, the agency may take action based upon the respondent's express admissions  
10 or upon other evidence and affidavits may be used as evidence without any notice to  
11 respondent.

12 12. Pursuant to its authority under Government Code section 11520, the Director after  
13 having reviewed the proof of service dated February 21, 2012, signed by Juana Mejia, finds  
14 Respondent is in default. The Director will take action without further hearing and, based on  
15 Accusation, No. 79/12-75, proof of service and on the Affidavit of Bureau Representative Brian  
16 Maclean, finds that the allegations in Accusation are true.

17 13. Taking official notice of its own internal records, pursuant to Business and  
18 Professions Code section 125.3, it is hereby determined that the reasonable costs for Investigation  
19 and Enforcement is \$10,272.50 as of September 23, 2013.

20 **DETERMINATION OF ISSUES**

21 1. Based on the foregoing findings of fact, Respondent Abe I, Rabadi, dba Smog Stop  
22 Test Only, has subjected his Automotive Repair Dealer Registration No. ARD 259545, his Smog  
23 Check-Test Only Station License No. TC 259545 and his Smog Check Inspector License No. EO  
24 631177 to discipline.

25 2. The agency has jurisdiction to adjudicate this case by default.

26 3. The Director of Consumer Affairs is authorized to revoke Respondent's Automotive  
27 Repair Dealer License Number ARD 259545, Smog Check-Test Only Station License No. TC  
28 259545, and Smog Check Inspector License No. EO 631177 based upon the following violations  
alleged in the Accusation which are supported by the evidence contained in the affidavit of  
Bureau Representative Brian Maclean in this case:

1 a. Respondent committed multiple violations of Business & Professions Code section  
2 9884.7 and Health & Safety Code section 44072.2 in that a total of twenty vehicles were clean  
3 plugged at Respondent's shop, sixteen of which were clean plugged by Respondent using his  
4 technician license between, April 1, 2011 and May 31, 2011.

5 **ORDER**

6 IT IS SO ORDERED that Automotive Repair Dealer Registration No. ARD 259545, Smog  
7 Check-Test Only Station License No. TC 259545 and Smog Check Inspector License No. EO  
8 631177 heretofore issued to Respondent, Abe I Rabadi, are revoked.

9 Pursuant to Government Code section 11520, subdivision (c), Respondent may serve a  
10 written motion requesting that the Decision be vacated and stating the grounds relied on within  
11 seven (7) days after service of the Decision on Respondent. The motion should be sent to the  
12 Bureau of Automotive Repair, ATTN: William D. Thomas, 10949 North Mather Boulevard,  
13 Rancho Cordova, CA 95670. The agency in its discretion may vacate the Decision and grant a  
14 hearing on a showing of good cause, as defined in the statute.

15 This Decision shall become effective on NOV 20 2013.

1 Complainant alleges:

2 **PARTIES/LICENSE INFORMATION**

3 1. Patrick Dorais (Complainant) brings this First Amended Accusation solely in his  
4 official capacity as the Acting Chief of the Bureau of Automotive Repair (Bureau), Department of  
5 Consumer Affairs.

6 **Smog Stop Test Only; Abe I. Rabadi, Owner**

7 2. On or about September 25, 2009, the Director of Consumer Affairs (Director) issued  
8 Automotive Repair Dealer Registration Number ARD 259545 (registration) to Abe I. Rabadi  
9 (Respondent Rabadi), owner of Smog Stop Test Only. On February 6, 2012, Respondent's  
10 registration was revoked; however, the revocation was stayed and Respondent was placed on  
11 probation for three (3) years on terms and conditions, as set forth in paragraph 33 below.

12 Respondent's registration expired on September 30, 2012, and has not been renewed.

13 3. On or about September 29, 2009, the Director issued Smog Check, Test Only, Station  
14 License Number TC 259545 (smog check station license) to Respondent Rabadi. On February 6,  
15 2012, Respondent's smog check station license was revoked; however, the revocation was stayed  
16 and Respondent was placed on probation for three (3) years on terms and conditions, as set forth  
17 in paragraph 33 below. Respondent's smog check station license expired on September 30, 2012,  
18 and has not been renewed.

19 **A & Z Smog Test Only; Abe I. Rabadi, Owner**

20 4. On or about March 2, 2010, the Director issued Automotive Repair Dealer  
21 Registration Number ARD 261018 to Respondent Rabadi, owner of A & Z Smog Test Only. On  
22 February 6, 2012, Respondent's registration was revoked, as set forth in paragraph 33 below.

23 5. On or about April 22, 2010, the Director issued Smog Check, Test Only, Station  
24 License Number TC 261018 to Respondent Rabadi, owner of A & Z Smog Test Only. On  
25 February 6, 2012, Respondent's smog check station license was revoked, as set forth in paragraph  
26 33 below.

27 ///

28 ///



1 Affairs, or a court of law, or the voluntary surrender of the license shall not deprive the Director  
2 of jurisdiction to proceed with disciplinary action.

3 12. California Code of Regulations, title 16, section 3340.28, subdivision (e), states:

4 "Upon renewal of an unexpired Basic Area Technician license or an Advanced Emission  
5 Specialist Technician license issued prior to the effective date of this regulation, the licensee may  
6 apply to renew as a Smog Check Inspector, Smog Check Repair Technician, or both."

7 **STATUTORY PROVISIONS**

8 13. Bus. & Prof. Code section 9884.7 states, in pertinent part:

9 (a) The director, where the automotive repair dealer cannot show there  
10 was a bona fide error, may deny, suspend, revoke or place on probation the  
11 registration of an automotive repair dealer for any of the following acts or omissions  
12 related to the conduct of the business of the automotive repair dealer, which are done  
13 by the automotive repair dealer or any automotive technician, employee, partner,  
14 officer, or member of the automotive repair dealer.

15 (1) Making or authorizing in any manner or by any means whatever any  
16 statement written or oral which is untrue or misleading, and which is known, or which  
17 by the exercise of reasonable care should be known, to be untrue or misleading.

18 . . . .

19 (4) Any other conduct that constitutes fraud.

20 . . . .

21 (c) Notwithstanding subdivision (b), the director may suspend, revoke or  
22 place on probation the registration for all places of business operated in this state by  
23 an automotive repair dealer upon a finding that the automotive repair dealer has, or is,  
24 engaged in a course of repeated and willful violations of this chapter, or regulations  
25 adopted pursuant to it.

26 14. Code section 22, subdivision (a), states:

27 "Board" as used in any provision of this Code, refers to the board in  
28 which the administration of the provision is vested, and unless otherwise expressly  
provided, shall include "bureau," "commission," "committee," "department,"  
"division," "examining committee," "program," and "agency."

15. Code section 477, subdivision (b), states, in pertinent part, that a "license" includes  
"registration" and "certificate."

1 16. Health & Saf. Code section 44072.2 states, in pertinent part:

2 The director may suspend, revoke, or take other disciplinary action  
3 against a license as provided in this article if the licensee, or any partner, officer, or  
4 director thereof, does any of the following:

5 (a) Violates any section of this chapter [the Motor Vehicle Inspection  
6 Program (Health and Saf. Code § 44000, et seq.)) and the regulations adopted  
7 pursuant to it, which related to the licensed activities.

8 . . . .

9 (c) Violates any of the regulations adopted by the director pursuant to  
10 this chapter.

11 (d) Commits any act involving dishonesty, fraud, or deceit whereby  
12 another is injured

13 . . .

14 17. Health & Saf. Code section 44072.10 states, in pertinent part:

15 . . . .

16 (c) The department shall revoke the license of any smog check technician  
17 or station licensee who fraudulently certifies vehicles or participates in the fraudulent  
18 inspection of vehicles. A fraudulent inspection includes, but is not limited to, all of  
19 the following:

20 . . . .

21 (4) Intentional or willful violation of this chapter or any regulation,  
22 standard, or procedure of the department implementing this chapter . . .

23 18. Health & Saf. Code section 44072.8 states that when a license has been revoked or  
24 suspended following a hearing under this article, any additional license issued under this chapter  
25 in the name of the licensee may be likewise revoked or suspended by the director.

26 **COST RECOVERY**

27 19. Bus. & Prof. Code section 125.3 provides, in pertinent part, that a Board may request  
28 the administrative law judge to direct a licensee found to have committed a violation or  
violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation  
and enforcement of the case.

**BACKGROUND**

20. In or about May 2011, the Bureau initiated an investigation of Respondent Rabadi's  
smog check station, Smog Stop Test Only, based on a review of information from the Bureau's

1 Vehicle Information Database (VID) which indicated that Rabadi and/or his employees may be  
2 engaging in fraudulent smog check inspections.

3 21. On May 31, 2011, a representative of the Bureau conducted a detailed review of the  
4 VID data for all smog inspections performed at Rabadi's facility for the period of April 1, 2011,  
5 through May 31, 2011. The representative found that the VID recorded the same two diagnostic  
6 trouble codes (code) during the OBD II test<sup>2</sup> on the 20 vehicles identified below regardless of the  
7 make or model of the vehicle. The Bureau obtained information indicating that the codes were  
8 not applicable to the vehicles. Respondent Rabadi performed the smog inspections on vehicles 1  
9 through 16; Respondent Zeit performed the inspections on vehicles 17 through 20. The Bureau  
10 concluded that Respondent Rabadi and Respondent Zeit performed the smog inspections on the  
11 vehicles using a method known as "clean plugging",<sup>3</sup> resulting in the issuance of fraudulent  
12 certificates of compliance for the vehicles.

21 <sup>2</sup> The On Board Diagnostic, generation II (OBD II), functional test is an automated  
22 function of the BAR-97 analyzer. During the OBD II functional test, the technician is required to  
23 connect an interface cable from the BAR-97 analyzer to a Diagnostic Link Connector (DLC)  
24 which is located inside the vehicle. Through the DLC, the BAR-97 analyzer automatically  
retrieves information from the vehicle's on-board computer about the status of the readiness  
indicators, trouble codes, and the MIL (malfunction indicator light). If the vehicle fails the OBD  
II functional test, it will fail the overall inspection.

25 <sup>3</sup> Clean-plugging is the use of the OBD II readiness monitor status and stored fault code  
26 (trouble code) status of a passing vehicle for the purpose of illegally issuing a smog certificate to  
27 another vehicle that is not in compliance due to a failure to complete the minimum number of self  
tests, known as monitors, or due to the presence of a stored fault code that indicates an emission  
control system or component failure.

**FIRST CAUSE FOR DISCIPLINE**

**(Untrue or Misleading Statements)**

22. Respondent Rabadi's registration is subject to disciplinary action pursuant to Bus. & Prof. Code section 9884.7, subdivision (a)(1), in that Respondent made or authorized statements which he knew or in the exercise of reasonable care should have known to be untrue or misleading, as follows:

a. Respondent Rabadi certified that vehicles 1 through 16, identified in paragraph 21 above, had passed inspection and were in compliance with applicable laws and regulations. In fact, Respondent conducted the inspections on the vehicles using clean-plugging methods in that he substituted or used a different vehicle (s) during the OBD II functional tests in order to issue

1 smog certificates of compliance for the vehicles, and did not test or inspect the vehicles as  
2 required by Health & Saf. Code section 44012.

3 b. Respondent Rabadi's technician, Respondent Zeit, certified that vehicles 17 through  
4 20, identified in paragraph 21 above, had passed inspection and were in compliance with  
5 applicable laws and regulations. In fact, Respondent Zeit conducted the inspections on the  
6 vehicles using clean-plugging methods in that he substituted or used a different vehicle (s) during  
7 the OBD II functional tests in order to issue smog certificates of compliance for the vehicles, and  
8 did not test or inspect the vehicles as required by Health & Saf. Code section 44012.

9 **SECOND CAUSE FOR DISCIPLINE**

10 **(Fraud)**

11 23. Respondent Rabadi's registration is subject to disciplinary action pursuant to Bus. &  
12 Prof. Code section 9884.7, subdivision (a)(4), in that Respondent committed acts that constitute  
13 fraud by issuing electronic smog certificates of compliance for vehicles 1 through 20, identified in  
14 paragraph 21 above, without performing bona fide inspections of the emission control devices  
15 and systems on the vehicles, thereby depriving the People of the State of California of the  
16 protection afforded by the Motor Vehicle Inspection Program.

17 **THIRD CAUSE FOR DISCIPLINE**

18 **(Violations of the Motor Vehicle Inspection Program)**

19 24. Respondent Rabadi's smog check station license is subject to disciplinary action  
20 pursuant to Health & Saf. Code section 44072.2, subdivision (a), in that Respondent failed to  
21 comply with the following sections of that Code:

22 a. **Section 44012:** Respondent failed to ensure that the emission control tests were  
23 performed on vehicles 1 through 20, identified in paragraph 21 above, in accordance with  
24 procedures prescribed by the department.

25 b. **Section 44015:** Respondent issued electronic smog certificates of compliance for  
26 vehicles 1 through 20, identified in paragraph 21 above, without ensuring that the vehicles were  
27 properly tested and inspected to determine if they were in compliance with Health & Saf. Code  
28 section 44012.







1 Automotive Repair Dealer Registration Number ARD 259545 and Smog Check, Test Only,  
2 Station License Number TC 259545, issued to him as owner of Smog Stop Test Only, were also  
3 revoked<sup>4</sup>; however, the revocations were stayed and Rabadi was placed on probation for three (3)  
4 years on terms and conditions. Rabadi admitted that he "clean piped"<sup>5</sup> two Bureau undercover  
5 vehicles, in violation of Bus. & Prof. Code section 9884.7, subdivisions (a)(1) (untrue or  
6 misleading statements) and (a)(4) (fraud); and Health & Saf. Code sections 44072.2, subdivision  
7 (a) (violations of Health & Saf. Code sections 44012, subdivision (a), 44012, subdivision (f),  
8 44015, subdivision (b, and 44059); 44072.2, subdivision (c) (violations of California Code of  
9 Regulations, title 16, sections 3340.24, subdivision (c), 3340.35, subdivision (c), and 3340.42),  
10 and 44072.2, subdivision (d) (dishonesty, fraud or deceit). Rabadi also admitted that he allowed  
11 Respondent Samer George Zait to participate in the smog inspection of one of the undercover  
12 vehicles while Samer George Zait's technician license was expired, in violation of Health & Saf.  
13 Code sections 44072.2, subdivision (f) (aiding and abetting unlicensed activity), and 44072.2,  
14 subdivision (a) (violation of Health & Saf. Code section 44014, subdivision (a)).

#### 15 OTHER MATTERS

16 34. Pursuant to Bus. & Prof. Code section 9884.7, subdivision (c), the Director may  
17 suspend, revoke or place on probation the registration for all places of business operated in this  
18 state by Respondent Abe I. Rabadi, owner of Smog Stop Test Only, upon a finding that  
19 Respondent has, or is, engaged in a course of repeated and willful violations of the laws and  
20 regulations pertaining to an automotive repair dealer.

21 35. Pursuant to Health & Saf. Code section 44072.8, if Smog Check, Test Only, Station  
22 License Number TC 259545, issued to Abe I. Rabadi, owner of Smog Stop Test Only, is revoked

2 likewise revoked or suspended by the director.

3 36. Pursuant to Health & Saf. Code section 44072.8, if Smog Check Inspector License  
4 Number EO 631177, (formerly Advanced Emission Specialist Technician License Number EA  
5 631177), issued to Abe I. Rabadi, is revoked or suspended, any additional license issued under  
6 this chapter in the name of said licensee may be likewise revoked or suspended by the director.

7 37. Pursuant to Health & Saf. Code section 44072.8, if Advanced Emission Specialist  
8 Technician License Number EA 632736, upon renewal and redesignation as EO 632736 and/or  
9 EI 632736, issued to Yousef K. Zeit, is revoked or suspended, any additional license issued under  
10 this chapter in the name of said licensee may be likewise revoked or suspended by the director.

11 **PRAYER**

12 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,  
13 and that following the hearing, the Director of Consumer Affairs issue a decision:

14 1. Revoking or suspending Automotive Repair Dealer Registration Number ARD  
15 259545, issued to Abe I. Rabadi, owner of Smog Stop Test Only;

16 2. Revoking or suspending any other automotive repair dealer registration issued to Abe  
17 I. Rabadi;

18 3. Revoking or suspending Smog Check, Test Only, Station License Number  
19 TC 259545, issued to Abe I. Rabadi, owner of Smog Stop Test Only;

20 4. Revoking or suspending Smog Check Inspector License Number EO 631177,  
21 (formerly Advanced Emission Specialist Technician License Number EA 631177), issued to Abe  
22 I. Rabadi;

23 5. Revoking or suspending any additional license issued under Chapter 5 of the Health  
24 and Safety Code in the name of Abe I. Rabadi;

25 6. Revoking or suspending Advanced Emission Specialist Technician License Number  
26 EA 632736, as redesignated Smog Check Inspector License Number EO 632736 and/or Smog  
27 Check repair Technician License Number EI 632736, issued to Yousef K. Zeit;
