

26 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-
27 entitled proceedings that the following matters are true:
28

1. PARTIES

2 1. Patrick Dorais (Complainant) is the Chief of the Bureau of Automotive Repair
3 (Bureau). He brought this action solely in his official capacity and is represented in this matter by
4 Xavier Becerra, Attorney General of the State of California, by Shawn P. Cook, Supervising
5 Deputy Attorney General.

6 2. Respondent Ortega Smog Check; Lily Ortega (Respondent) is represented in this
7 proceeding by attorney Marvin E. Vallejo, whose address is: P. O. Box 86788; Los Angeles, CA
8 90086.

9 3. On or about September 13, 2013, the Bureau issued Automotive Repair Dealer
10 Registration No. ARD 274250 to Ortega Smog Check; Lily Ortega (Respondent). The
11 Automotive Repair Dealer Registration was in full force and effect at all times relevant to the
12 charges brought in Accusation No. 79/16-85 and expired on September 30, 2015 and has not been
13 renewed.

14 4. On or about October 17, 2013, the Bureau issued Smog Check Test Only Station
15 License No. TC 274250 to Ortega Smog Check; Lily Ortega (Respondent). The Smog Check
16 Test Only Station License was in full force and effect at all times relevant to the charges brought
17 in Accusation No. 79/16-85 and expired on September 30, 2015 and has not been renewed.

18 5. On or about November 30, 2015, the Director issued Smog Check Inspector License
19 No. EO 635907 to Christian Godinez ("Respondent Godinez"). The license was in full force and
20 effect at all times relevant to the charges brought herein and expired on November 30, 2017 and
21 has not been renewed.

22 JURISDICTION

23 6. Accusation No. 79/16-85 was filed before the Director, and is currently pending
24 against Respondent. The Accusation and all other statutorily required documents were properly
25 served on Respondent on March 21, 2016. Respondent timely filed her Notice of Defense
26 contesting the Accusation.

27 7. A copy of Accusation No. 79/16-85 is attached as exhibit A and incorporated herein
28 by reference.

1 this stipulation as the Decision and Order, the Stipulated Settlement and Disciplinary Order shall
2 be of no force or effect, except for this paragraph, it shall be inadmissible in any legal action
3 between the parties, and the Director shall not be disqualified from further action by having
4 considered this matter.

5 14. The parties understand and agree that Portable Document Format (PDF) and facsimile
6 copies of this Stipulated Settlement and Disciplinary Order, including PDF and facsimile
7 signatures thereto, shall have the same force and effect as the originals.

8 15. This Stipulated Settlement and Disciplinary Order is intended by the parties to be an
9 integrated writing representing the complete, final, and exclusive embodiment of their agreement.
10 It supersedes any and all prior or contemporaneous agreements, understandings, discussions,
11 negotiations, and commitments (written or oral). This Stipulated Settlement and Disciplinary
12 Order may not be altered, amended, modified, supplemented, or otherwise changed except by a
13 writing executed by an authorized representative of each of the parties.

14 16. In consideration of the foregoing admissions and stipulations, the parties agree that
15 the Director may, without further notice or formal proceeding, issue and enter the following
16 Disciplinary Order:

17 **DISCIPLINARY ORDER**

18 IT IS HEREBY ORDERED that Automotive Repair Dealer Registration No. ARD 274250
19 and Smog Check Test Only Station License No. TC 274250 issued to Respondent Lily Ortega,
20 dba Ortega Smog Check and Smog Check Inspector License No. EO 635907 issued to
21 Respondent Christian Godinez are each and all revoked.

22 1. **Cost Recovery.** The parties understand and agree that for purposes of settlement of
23 this matter, the Bureau waives its right to recover its reasonable costs of investigation and
24 prosecution of Accusation No. 79/16-85 pursuant to Bus. and Prof. Code sec. 125.3. However,
25 the parties understand and agree that should either Respondent apply in the future for any
26 registration or license issued by the Bureau the costs of investigation and prosecution in this
27 matter of \$10,163, shall then be due and payable, jointly and severally.



24 **PARTIES**

25 1. Patrick Dorais ("Complainant") brings this Accusation solely in his official capacity
26 as the Chief of the Bureau of Automotive Repair ("Bureau"), Department of Consumer Affairs.

2 STATUTORY PROVISIONS

3 9. Section 9884.7 of the Business and Professions Code ("Code") states, in pertinent
4 part:

5 "(a) The director, where the automotive repair dealer cannot show there was a bona
6 fide error, may refuse to validate, or may invalidate temporarily or permanently, the
7 registration of an automotive repair dealer for any of the following acts or omissions related
8 to the conduct of the business of the automotive repair dealer, which are done by the
9 automotive repair dealer or any automotive technician, employee, partner, officer, or
10 member of the automotive repair dealer.

11 "(1) Making or authorizing in any manner or by any means whatever any statement
12 written or oral which is untrue or misleading, and which is known, or which by the exercise
13 of reasonable care should be known, to be untrue or misleading.

14 "(4) Any other conduct which constitutes fraud.

15 "(6) Failure in any material respect to comply with the provisions of this chapter [the
16 Automotive Repair Act (Bus. & Prof. Code, § 9880, et seq.)] or regulations adopted
17 pursuant to it.

18 "(b) Except as provided for in subdivision (c), if an automotive repair dealer operates
19 more than one place of business in this state, the director pursuant to subdivision (a) shall
20 only refuse to validate, or shall only invalidate temporarily or permanently the registration
21 of the specific place of business which has violated any of the provisions of this chapter.
22 This violation, or action by the director, shall not affect in any manner the right of the
23 automotive repair dealer to operate his or her other places of business.

24 "(c) Notwithstanding subdivision (b), the director may refuse to validate, or may
25 invalidate temporarily or permanently, the registration for all places of business operated in
26 this state by an automotive repair dealer upon a finding that the automotive repair dealer
27 has, or is, engaged in a course of repeated and willful violations of this chapter, or
28 regulations adopted pursuant to it."

10. Section 17200 of the Code states:

23 "As used in this chapter, unfair competition shall mean and include any unlawful,
24 unfair or fraudulent business act or practice and unfair, deceptive, untrue or misleading
25 advertising and any act prohibited by Chapter 1 (commencing with Section 17500) of Part
26 3 of Division 7 of the Business and Professions Code."

11. Section 17500 of the Code states, in pertinent part:

It is unlawful for any person, firm, corporation. . . or any employee thereof with
intent. . . to dispose of. . . property or to perform services, professional or otherwise, . . . to
make or disseminate or cause to be made or disseminated before the public in this state, or

1 to make or disseminate. . . before the public. . . any statement, concerning that. . . property
2 or those services, professional or otherwise, . . . which is untrue or misleading, and which is
3 known, or which by the exercise of reasonable care should be known, to be untrue or
4 misleading. . .”

5 12. Section 477 of the Code provides, in pertinent part, that “Board” includes “bureau,”
6 “commission,” “committee,” “department,” “division,” “examining committee,” “program,”
7 and “agency.” “License” includes certificate, registration or other means to engage in a
8 business or profession regulated by the Code.

9 13. Section 118(b) of the Code states:

10 “The suspension, expiration, or forfeiture by operation of law of a license
11 issued by a board in the department, or its suspension, forfeiture, or cancellation by
12 order of the board or by order of a court of law, or its surrender without the written
13 consent of the board, shall not, during any period in which it may be renewed,
14 restored, reissued, or reinstated, deprive the board of its authority to institute or
15 continue a disciplinary proceeding against the licensee upon any ground provided by
16 law or to enter an order suspending or revoking the license or otherwise taking
17 disciplinary action against the licensee on any such ground.”

18 14. Section 44012 of the Health and Safety Code states, in pertinent part:

19 “The test at the smog check station shall be performed in accordance with procedures
20 prescribed by the department.

21 “(f) A visual or functional check is made of emission control devices specified by the
22 department. “

23 15. Section 44015 of the Health and Safety Code states, in pertinent part:

24 “(b) If a vehicle meets the requirements of Section 44012, a smog check station
25 licensed to issue certificates shall issue a certificate of compliance or a certificate of
26 noncompliance.”

27 16. Section 44032 of the Health and Safety Code states:

28 “No person shall perform, for compensation, tests or repairs of emission control
devices or systems of motor vehicles required by this chapter unless the person performing
the test or repair is a qualified smog check technician and the test or repair is performed at a
licensed smog check station. Qualified technicians shall perform tests of emission control
devices and systems in accordance with Section 44012.”

17. Section 44072.2 of the Health and Safety Code states, in pertinent part:

1 identification information or emission control system identification data for any
2 vehicle other than the one being tested. Nor shall any person knowingly enter into the
3 emissions inspection system any false information about the vehicle being tested.

4 24. Section 3340.42 of the California Code of Regulations, states, in pertinent part
5 that licensed smog check stations and technicians shall conduct tests and inspections in
6 accordance with smog check emissions test methods and standards.

7 COST RECOVERY

8 25. Code section 125.3 provides, in pertinent part, that a Board may request the
9 administrative law judge to direct a licentiate found to have committed a violation or violations of
10 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and
11 enforcement of the case.

12 FACTUAL BACKGROUND

13 26. During a routine smog check data review, a Bureau representative found abnormal
14 oxygen readings on all of the inspections conducted at Respondent Ortega Smog. On October 7,
15 2014, the Bureau performed an audit at Ortega Smog and found a defective oxygen sensor in the
16 EIS (the station's Emission Inspection System computer), the exhaust sample hose was installed
17 backward, and a gas cap adaptor was missing. As a result of the observed deficiencies, the Bureau
18 subsequently conducted undercover surveillance operations at Ortega Smog on December 4 and
19 11, 2014.

20 UNDERCOVER OPERATION OF DECEMBER 4, 2014

21 27. On December 4, 2014, Bureau representatives conducted an undercover video
22 surveillance of Respondent Ortega Smog. During the surveillance they accessed the state's
23 vehicle information database ("VID") and later printed out a Test Summary Report for the
24 vehicles tested that day. After each smog inspection they compared the actual vehicle tested with
25 the test details entered into the VID to determine whether the inspections were legitimate. The
26 VID data summary indicated Respondent Godinez performed all of the inspections and the
27 representatives personally recognized Godinez from a driver's license photo they had previously
28 obtained.

28 28. Vehicles of model year 1995 and older require performance of a Low Pressure Fuel

1 Evaporative Test ("LPFET") as a component of an official smog check inspection. The LPFET
2 requires a smog technician to install an adaptor and hose to the vehicle's fuel fill pipe and "pinch
3 off" or close the vapor line in the engine compartment. The vehicle's fuel system is then
4 pressurized with nitrogen gas. If a leak exceeding the prescribed test limit is detected, the vehicle
5 fails the LPFET, and the overall test result for the smog inspection should also be a fail.

6 29. During the December 4, 2014 surveillance, at least four vehicles which required an
7 LPFET passed smog inspections conducted by Respondents Godinez and Ortega Smog, even
8 though Bureau representatives observed that none of these vehicles received an LPFET. The
9 representatives did not see the gas cap door open on any of these vehicles, nor did they see any
10 hoses connected to the gas cap areas of the vehicles. However, for each of these vehicles
11 Respondent Godinez manually entered "pass" into the vehicle information database for the
12 LPFET and subsequently issued electronic smog certificates of compliance, even though none of
13 the vehicles would have passed a valid smog inspection.

14 UNDERCOVER OPERATION OF DECEMBER 11, 2014

15 30. On December 11, 2014, Bureau representatives conducted a second undercover video
16 surveillance at Respondent Ortega Smog. During the surveillance they again accessed the state's
17 vehicle information database ("VID") and later printed out a Test Summary Report for the
18 vehicles tested that day. After each smog inspection they again compared the actual vehicle
19 tested with the test details entered into the VID to determine whether the inspections were
20 legitimate. The VID data summary again indicated Respondent Godinez performed all of the
21 inspections that day.

22 31. Between 1530 hours and 1537 hours on December 11, 2014, Respondents Godinez
23 and Ortega Smog conducted a smog inspection of a 1993 Cadillac. During the inspection, Bureau
24 representatives observed that the gas cap door remained closed and no hose was ever connected to
25 the gas cap area, making it impossible to perform an LPFET. Nevertheless, Respondent Godinez
26 manually entered "pass" into the vehicle information database for the LPFET and subsequently
27 issued an electronic smog certificates of compliance for the Cadillac, even though it would not
28 have passed a valid smog inspection.

32. The following chart illustrates the fraudulent smog check inspections observed on December 4 and 11, 2014, at Respondent Ortega Smog:

FIRST CAUSE FOR DISCIPLINE

(Untrue or Misleading Statements)

33. Respondent Ortega Smog's registration is subject to disciplinary action pursuant to Code section 9884.7, subdivision (a)(1), in that on or about December 4 and 11, 2014, it made or authorized statements which it knew, or in the exercise of reasonable care should have known, to be untrue or misleading as follows: Respondent Ortega Smog certified that at least five "1995 model year or older" vehicles had passed inspection and were in compliance with applicable laws and regulations when in fact, Respondent Ortega Smog conducted the inspections on the vehicle without performing all portions of a smog check inspection including the LPFET, as required by Health and Safety Code section 44012. Complainant refers to, and by this reference incorporates, the allegations set forth above in paragraphs 26 through 32 above, as though set forth fully herein.

SECOND CAUSE FOR DISCIPLINE

(Fraud)

34. Respondent Ortega Smog's registration is subject to disciplinary action pursuant to

1 Code section 9884.7, subdivision (a)(4), in that on or about December 4 and 11, 2014, it
2 committed acts that constitute fraud by issuing electronic smog Certificates of Compliance for at
3 least five "1995 model year or older" vehicles without performing bona fide inspections of the
4 emission control devices and systems on the vehicles, thereby depriving the People of the State of
5 California of the protection afforded by the Motor Vehicle Inspection Program. Complainant
6 refers to, and by this reference incorporates, the allegations set forth above in paragraphs 26
7 through 32 above, as though set forth fully herein.

8 **THIRD CAUSE FOR DISCIPLINE**

9 **(Material Violation of Automotive Repair Act)**

10 35. Respondent Ortega Smog's registration is subject to disciplinary action pursuant to
11 Code section 9884.7, subdivision (a)(6), in that on or about December 4 and 11, 2014, it failed in
12 a "material respect to comply with the provisions of this chapter or regulations adopted pursuant
13 to it" when it issued electronic certificates of compliance for certain vehicles without performing
14 bona fide inspections of the emission control devices and systems on those vehicles, thereby
15 depriving the People of the State of California of the protection afforded by the Motor Vehicle
16 Inspection Program. Complainant refers to, and by this reference incorporates, the allegations set
17 forth above in paragraphs 26 through 32 above, as though set forth fully herein.

18 **FOURTH CAUSE FOR DISCIPLINE**

19 **(False or Misleading Statements)**

20 36. Respondent Ortega Smog's registration is subject to disciplinary action pursuant to
21 Code section 17500, in that on or about December 4 and 11, 2014, it disseminated untrue or
22 misleading information into the state's database that the LPFET portions of smog inspections had
23 been performed on at least five "1995 model year or older" vehicles when, in fact, they had not,
24 and by issuing electronic smog certificates of compliance to those same vehicles which would not
25 have passed a valid smog inspection. Complainant refers to, and by this reference incorporates,
26 the allegations set forth above in paragraphs 26 through 32 above, as though set forth fully herein.

27 ///

28 ///

1 FIFTH CAUSE FOR DISCIPLINE

2 (Violation of the Motor Vehicle Inspection Program)

3 37. Respondent Ortega Smog has subjected its station license to discipline under
4 Health & Saf. Code section 44072.2, subdivision (a), in that on or about December 4 and 11,
5 2014, it violated the following sections of the Health & Saf. Code with respect to the inspection
6 of certain vehicles:

7 a. **Section 44012:** Respondent failed to ensure that the emission control tests were
8 performed on those vehicles in accordance with procedures prescribed by the department.

9 b. **Section 44015, subdivision (b):** Respondent issued electronic certificates of
10 compliance without properly testing and inspecting the vehicles to determine if they were in
11 compliance with section 44012 of the Health & Saf. Code.

12 c. **Section 44032:** Respondent failed to perform tests of the emission control devices
13 and systems on those vehicles in accordance with section 44012 of the Health & Saf. Code.

14 Complainant refers to, and by this reference incorporates, the allegations set forth above in
15 paragraphs 26 through 32 above, as though set forth fully herein.

16 SIXTH CAUSE FOR DISCIPLINE

17 (Failure to Comply with Regulations Pursuant to the Motor Vehicle Inspection Program)

18 38. Respondent Ortega Smog has subjected its station license to disciplinary action
19 pursuant to Health & Safety Code section 44072.2, subdivision (c), in that on or about December
20 4 and 11, 2014, it failed to comply with provisions of California Code of Regulations, title 16, as
21 follows:

22 a. **Section 3340.24, subdivision (c):** Respondent falsely or fraudulently issued
23 electronic smog Certificates of Compliance without performing bona fide inspections on the
24 emission control devices and systems on those vehicles as required by Health & Saf. Code section
25 44012.

26 b. **Section 3340.30, subdivision (a):** Respondent failed to inspect and test vehicles in
27 accordance with Health & Saf. Code sections 44012 and 44035, and California Code of
28 Regulations, title 16, section 3340.42.

1 c. Section 3340.35, subdivision (c): Respondent issued electronic smog Certificates
2 of Compliance for vehicles even though the vehicles had not been inspected in accordance with
3 section 3340.42.

4 d. Section 3340.42: Respondent failed to ensure that the required smog tests were
5 conducted on vehicles in accordance with Bureau specifications.

6 Complainant refers to, and by this reference incorporates, the allegations set forth above in
7 paragraphs 26 through 32 above, as though set forth fully herein.

8 **SEVENTH CAUSE FOR DISCIPLINE**

9 **(Dishonesty, Fraud, or Deceit)**

10 39. Respondent Ortega Smog has subjected its station license to disciplinary action
11 pursuant to Health & Safety Code section 44072.2, subdivision (d), in that on or about December
12 4 and 11, 2014, it committed dishonest, fraudulent, or deceitful acts whereby another is injured by
13 issuing electronic smog Certificates of Compliance for vehicles without performing bona fide
14 inspections of the emission control devices and systems on the vehicles, thereby depriving the
15 People of the State of California of the protection afforded by the Motor Vehicle Inspection
16 Program.

17 Complainant refers to, and by this reference incorporates, the allegations set forth above in
18 paragraphs 26 through 32 above, as though set forth fully herein.

19 **EIGHTH CAUSE FOR DISCIPLINE**

20 **(Violations of the Motor Vehicle Inspection Program)**

21 40. Respondent Godinez has subjected his Smog Check Inspector License to disciplinary
22 action pursuant to Health & Safety Code section 44072.2, subdivision (a), in that on or about
23 December 4 and 11, 2014, he failed to comply with the following sections of that Code:

24 a. Section 44012, subdivision (a): Respondent failed to ensure that all emission control
25 devices and systems required by law for the vehicles tested were installed and functioning
26 correctly in accordance with test procedures.

27 b. Section 44012, subdivision (f): Respondent failed to perform the emissions control
28 tests on the vehicles in accordance with procedures prescribed by the department.

1 c. **Section 44032:** Respondent failed to perform tests of the emission control devices and
2 systems on vehicles in accordance with section 44012, in that the LPFET portions of the
3 inspections were not performed.

4 d. **Section 44059:** Respondent willfully made false entries for electronic Certificates of
5 Compliance for vehicles tested by certifying that they had been inspected as required when, in
6 fact, they had not.

7 Complainant refers to, and by this reference incorporates, the allegations set forth above in
8 paragraphs 26 through 32 above, as though set forth fully herein.

9 **NINTH CAUSE FOR DISCIPLINE**

10 **(Failure to Comply with Regulations Pursuant to the Motor Vehicle Inspection Program)**

11 41. Respondent Godinez has subjected his Smog Check Inspector License to disciplinary
12 action pursuant to Health & Safety Code section 44072.2, subdivision (c), in that on or about
13 December 4 and 11, 2014, he failed to comply with provisions of California Code of Regulations,
14 title 16, as follows:

15 a. **Section 3340.30, subdivision (a):** Respondent failed to inspect vehicles in accordance
16 with Health & Safety Code section 44012, and California Code of Regulations, title 16, section
17 3340.42.

18 b. **Section 3340.42:** Respondent failed to conduct all required portions of smog tests on
19 vehicles tested in accordance with the Bureau's specifications.

20 Complainant refers to, and by this reference incorporates, the allegations set forth above in
21 paragraphs 26 through 32 above, as though set forth fully herein.

22 **TENTH CAUSE FOR DISCIPLINE**

23 **(Dishonesty, Fraud, or Deceit)**

24 42. Respondent Godinez has subjected his Smog Check Inspector License to disciplinary
25 action pursuant to Health & Safety Code section 44072.2, subdivision (d), in that on or about
26 December 4 and 11, 2014, he committed dishonest, fraudulent, or deceitful acts whereby another
27 is injured by issuing electronic smog Certificates of Compliance for vehicles alleged tested
28 without performing bona fide inspections of the emission control devices and systems on the

1 vehicles, thereby depriving the People of the State of California of the protection afforded by the
2 Motor Vehicle Inspection Program.

3 Complainant refers to, and by this reference incorporates, the allegations set forth above in
4 paragraphs 26 through 32 above, as though set forth fully herein.

5 **ELEVENTH CAUSE FOR DISCIPLINE**

6 **(False or Misleading Statements)**

7 43. Respondent Godinez has subjected his Smog Check Inspector License to disciplinary
8 action pursuant to Bus. & Prof. Code section 17500, in that on or about December 4 and 11, 2014,
9 he disseminated untrue or misleading information into the state's database that the LPFET
10 portions of smog inspections had been performed on at least five "1995 model year or older"
11 vehicles when, in fact, they had not, and by issuing electronic smog certificates of compliance to
12 those same vehicles which would not have passed a valid smog inspection. Complainant refers to,
13 and by this reference incorporates, the allegations set forth above in paragraphs 26 through 32
14 above, as though set forth fully herein.

15 **OTHER MATTERS**

16 44. Pursuant to Bus. & Prof. Code section 9884.7, subdivision (c), the Director may
17 suspend, revoke or place on probation the registration for all places of business operated in this
18 state by Lily Ortega, owner of Ortega Smog Check, upon a finding that she has, or is, engaged in
19 a course of repeated and willful violations of the laws and regulations pertaining to an automotive
20 repair dealer.

21 45. Pursuant to Health & Safety Code section 44072.8, if Smog Check Station License
22 Number TC 274250, issued to Lily Ortega, owner of Ortega Smog Check, is revoked or
23 suspended, any additional license issued under the same chapter in the name of said licensee may
24 be likewise revoked or suspended by the Director.

25 46. Pursuant to Health & Safety Code section 44072.8, if Respondent Christian Godinez's
26 Smog Check Inspector License No. EO 635907 is revoked or suspended, any additional license
27 issued under this chapter in the name of said licensee may be likewise revoked or suspended by
28 the Director.

PRAYER

1
2 **WHEREFORE**, Complainant requests that a hearing be held on the matters herein
3 alleged, and that following the hearing, the Director issue a decision:

4 1. Revoking or suspending Automotive Repair Dealer Registration Number ARD
5 274250, issued to Lily Ortega, owner of Ortega Smog Check;

6 2. Revoking or suspending any other automotive repair dealer registration issued to Lily
7 Ortega;

8 3. Revoking or suspending Smog Check Station License Number TC 274250, issued to
9 Lily Ortega, owner of Ortega Smog Check;

10 4. Revoking or suspending Smog Check Inspector License No. EO 635907, issued to
11 Christian Godinez;

12 5. Revoking or suspending any additional license issued under Chapter 5 of the Health
13 and Safety Code in the name of Christian Godinez;

14 6. Ordering Lily Ortega, Ortega Smog Check, and Christian Godinez to pay the Director
15 the reasonable costs of the investigation and enforcement of this case, pursuant to Business and
16 Professions Code section 125.3; and

17 7. Taking such other and further action as deemed necessary and proper.
