2	PARTIES
3	1. Patrick Dorais (Complainant) brings this Accusation and Petition to Revoke
4	Probation solely in his official capacity as the Chief of the Bureau of Automotive Repair
5	(Bureau), Department of Consumer Affairs.
6	Respondent 905 Smog & Auto Repair
7	2. On or about October 3, 2005, the Bureau issued Automotive Repair Dealer
8	Registration Number ARD 240846 to Micar International, Inc. doing business as 905 Smog &
9	Auto Repair, with Miguel Angel Carranza as its President (905 Smog & Auto Repair). The
10	Automotive Repair Dealer Registration was in full force and effect at all times relevant to the
11	charges brought herein and will expire on July 31, 2018, unless renewed.
12	3. On or about October 26, 2005, the Bureau issued Smog Check Station License
13	Number RC 240846 to Respondent 905 Smog & Auto Repair. The Smog Check Station License
14	was in full force and effect at all times relevant to the charges brought herein and will expire on
15	July 31, 2018, unless renewed.
16	4. On or about October 13, 2005, the Bureau issued Lamp Station License Number LS
17	240846, Class A to 905 Smog & Auto Repair. The Lamp Station License was in full force and
18	effect at all times relevant to the charges brought herein and will expire on July 31, 2018, unless
19	renewed,
20	5. On or about October 13, 2005, the Bureau issued Brake Station License Number BS
21	240846, Class C to 905 Smog & Auto Repair. The Brake Station License was in full force and
22	effect at all times relevant to the charges brought herein and will expire on July 31, 2018, unless

25	6. On or about October 5, 2016, the Bureau issued Smog Check Inspector License
26	Number EO 638563 to Fernando Zuniga (Respondent Zuniga). The Smog Check Inspector
27	License was in full force and effect at all times relevant to the charges brought herein and will
28	expire on June 30, 2018, unless renewed.

7. On or about September 14, 2015, the Bureau issued Brake Adjuster License Number
 BA 638563, Class C to Respondent Zuniga. The Brake Adjuster License was in full force and
 effect at all times relevant to the charges brought herein and will expire on June 30, 2019, unless
 renewed.

8. On or about November 20, 2015, the Bureau issued Lamp Adjuster License Number
LA 638563, Class A to Respondent Zuniga. The Lamp Adjuster License was in full force and
effect at all times relevant to the charges brought herein and will expire on June 30, 2019, unless
renewed.

In a prior disciplinary action entitled Micar International, Inc. dba 905 Smog & Auto 9. 9 Repair, Miguel Angel Carranza, President; and Miguel Angel Carranza, Case No. 77/14-62, the 10Bureau issued a Decision and Order effective October 6, 2015, in which Respondent Miguel 11 12 Angel Carranza's Brake Adjuster License Number BA 138952, and Lamp Adjuster License Number LA 138952, were revoked. Respondent Micar International, Inc.'s Automotive Repair 13 14 Dealer Registration No. ARD 240846, Lamp Station License No. LS 240846, and Brake Station License No. BS 240846 were revoked. However, the revocation of Automotive Repair Dealer 15 Registration No. ARD 240846, Lamp Station License No. LS 240846, and Brake Station License 16 No. BS 240846 was stayed and Respondent was placed on probation for three (3) years on the 17 following terms and conditions. A copy of that Decision and Order is attached as Exhibit A and is 18 incorporated by reference. 19

JURISDICTION AND STATUTORY PROVISIONS FOR ACCUSATION

10. This Accusation is brought before the Director of the Department of Consumer Affairs (Director) for the Bureau of Automotive Repair, under the authority of the following laws.

Section 9889.1 of the Code provides, in pertinent part, that any license issued may be

suspended or revoked by the Bureau.

12. Section 9884.13 of the Code provides, in pertinent part, that the expiration of a valid
registration shall not deprive the Bureau of jurisdiction to proceed with a disciplinary proceeding
against an automotive repair dealer or to render a decision invalidating a registration temporarily
or permanently.

1	13. Section 9889.7 of the Code provides, in pertinent part, that the expiration or
2	suspension of a license, or the voluntary surrender of a license by a licensee shall not deprive the
3	Bureau of jurisdiction to proceed with any investigation of or action or disciplinary proceedings
4	against such licensee, or to render a decision suspending or revoking such license.
5	14. Section 9884.7 of the Code states:
6	(a) The director, where the automotive repair dealer cannot show there was a
7	bona fide error, may deny, suspend, revoke, or place on probation the registration of an automotive repair dealer for any of the following acts or omissions related to the
8	conduct of the business of the automotive repair dealer, which are done by the automotive repair dealer or any automotive technician, employee, partner, officer, or
9	member of the automotive repair dealer.
10	(1) Making or authorizing in any manner or by any means whatever any
10	statement written or oral which is untrue or misleading, and which is known, or which by the exercise of reasonable care should be known, to be untrue or misleading.
	· · ·
12	(4) Any other conduct which constitutes fraud.
13	
14	(6) Failure in any material respect to comply with the provisions of this
15	chapter or regulations adopted pursuant to it.
16	
17	(c) Notwithstanding subdivision (b), the director may suspend, revoke, or place on probation the registration for all places of business operated in this state by an
18	automotive repair dealer upon a finding that the automotive repair dealer has, or is, engaged in a course of repeated and willful violations of this chapter, or regulations
19	adopted pursuant to it.
20	15. Section 9884.8 of the Code states:
21	All work done by an automotive repair dealer, including all warranty work, shall be recorded on an invoice and shall describe all service work done and parts
22	supplied. Service work and parts shall be listed separately on the invoice, which shall also state separately the subtotal prices for service work and for parts, not including
23	sales tax, and shall state separately the sales tax, if any, applicable to each. If any used, rebuilt, or reconditioned parts are supplied, the invoice shall clearly state that
24	fact. If a part of a component system is composed of new and used, rebuilt or
25	reconditioned parts, that invoice shall clearly state that fact. The invoice shall include a statement indicating whether any crash parts are original equipment manufacturer
26	crash parts or nonoriginal equipment manufacturer aftermarket crash parts. One copy of the invoice shall be given to the customer and one copy shall be retained by the
27	automotive repair dealer.

8	Vehicle Code, he shall, when requested by the owner or driver of the vehicle, issue a certificate of adjustment on a form prescribed by the director, which certificate shall contain the date of issuance, the make and registration number of the vehicle, the
9	name of the owner of the vehicle, and the official license of the station.

11	false statement or entry with regard to a material matter in any oath, affidavit, certificate of
12	compliance or noncompliance constitutes perjury.

21	recommended procedures, as published in the manufacturers' vehicle service and repair manuals
22 23	21. California Code of Regulations, title 16, section 3316, subdivision (d)(2) provides, in
24	pertinent part, that when all of the lamps, lighting equipment, and related electrical systems on a
25	vehicle have been inspected and found to be in compliance with all requirements of the Vehicle
26	Code and Bureau regulations, the lamp adjustment certificate shall certify that the entire system
27	meets all of those requirements.

1	22. California Code of Regulations, title 16, section 3321, subdivision (c)(2) provides, in
2	pertinent part, that when the entire brake system on any vehicle has been inspected or tested and
3	found to be in compliance with all requirements of the Vehicle Code and Bureau regulations, and
4	the vehicle has been road-tested, the brake adjustment certificate shall certify that the entire
5	system meets all such requirements.
6	23. California Code of Regulations, title 16, section 3371, provides, in pertinent part, that
7	no dealer shall publish, utter, or make or cause to be published, uttered, or made any false or
8	misleading statement or advertisement which is known to be false or misleading, or which by the
9	exercise of reasonable care should be known to be false or misleading.
10	24. California Code of Regulations, title 16, section 3373, states:
11	No automotive repair dealer or individual in charge shall, in filling out an
12	estimate, invoice, or work order, or record required to be maintained by section 3340.15(f) of this chapter, withhold therefrom or insert therein any statement or
13	information which will cause any such document to be false or misleading, or where the tendency or effect thereby would be to mislead or deceive customers, prospective
14	customers, or the public.
15	COST RECOVERY
16	25. Section 125.3 of the Code provides, in pertinent part, that the Director may request
17	the administrative law judge to direct a licentiate found to have committed a violation or
18	violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation
19	and enforcement of the case, with failure of the licentiate to comply subjecting the license to not
20	being renewed or reinstated. If a case settles, recovery of investigation and enforcement costs
21	may be included in a stipulated settlement.
22	UNDERCOVER OPERATION #1
23	26. On July 11, 2016, a Bureau undercover operator drove a Bureau-documented 2006
24	Ford F150 truck to the 905 Smog & Auto Repair for repairs. The following introduced
25	malfunctions were placed on the vehicle: installation of a right front brake rotor that was
26	machined below the minimum thickness specifications and needed replacement, installation of
27	Tamper Indicators on each of the wheels to detect if any of the wheels had been removed, and
28	creation of a defect in the lighting system by misadjusting the left front headlamp and placing

Tamper Indicators on it to detect any adjustment(s). In order for this vehicle to properly pass an official brake and lamp inspection it would need to have the right front brake rotor replaced, and the left front headlamp would need to be adjusted correctly.

The undercover operator spoke with an employee at 905 Smog & Auto Repair and 27. 4 requested a Brake and Lamp inspection, and a Smog Check Inspection. The undercover operator 5 received an unsigned estimate of \$90.00 for the inspections. After the inspections were complete, 6 the employee told the undercover operator that the only thing that failed was the reverse lights. 7 The undercover operator paid \$90.00 in cash, and received a copy of the signed invoice, a copy of 8 the Vehicle Inspection Report for the Smog Check Inspection, the DMV vehicle registration 9 document, and the Certificate of Compliance-Brake Adjustment certificate indicating that the 10 license of Fernando Zuniga was used to perform the brake certification. The undercover operator 11 12 then left the facility and transferred custody of the vehicle to a Bureau representative.

28. A Bureau representative later reinspected the vehicle. The right front brake rotor that
was machined below the minimum thickness level remained on the vehicle, and the condition of
the right front brake rotor prevented the Ford F-150 from complying with the requirements of the
laws and regulation for issuance of a Certificate of Compliance-Brake Adjustment for the brake
system. Therefore, no Certificate of Compliance-Brake Adjustment should have been issued.

FIRST CAUSE FOR DISCIPLINE - 905 SMOG & AUTO REPAIR

(Untrue, False or Misleading Statements)

20 29. Respondent 905 Smog & Auto Repair has subjected its registration and licenses to 21 disciplinary action under Code section 9884.7(a)(1), and California Code of Regulations, title 16, 22 section 3371, in that it invoiced and charged for inspecting the entire brake system and issued a 23 Certificate of Compliance-Brake Adjustment stating the brake system was in compliance, when in 24 fact the vehicle should have failed the inspection. The invoice documented that the front disc 25 brake rotors were above the manufacturer service limits, when in fact the right front brake rotor 26 was below the minimum discard thickness.

UNDERCOVER OPERATION #2

34. On October 19, 2016, a Bureau undercover operator drove a Bureau-documented 4 1997 Toyota Camry to the 905 Smog & Auto Repair for repairs. The following introduced 5 malfunctions were placed on the vehicle: a right front brake rotor which was below the minimum 6 discard dimension (the brake rotor was below the minimum thickness level and was in need of 7 replacement), and Tamper Indicators were installed on the each of the wheels in order to detect if 8 any of the wheels had been removed. A defect was created in the lighting system by misaiming 9 the right front headlamp, and Tamper Indicators were placed on it to detect any adjustment(s). In 10order for this vehicle to properly pass an official brake and lamp inspection it would need to have 11 the front right brake rotor replaced, and the right front headlamp would need to be adjusted 12 correctly. 13

The undercover operator spoke with an employee at 905 Smog & Auto Repair and 35. 14 requested a Brake and Lamp inspection, and a Smog Check Inspection. The undercover operator 15 received an unsigned estimate of \$90.00 for the inspections. After the inspections were complete, 16 the undercover operator paid \$90.00 in cash, and received a copy of the signed invoice, a copy of 17 the Vehicle Inspection Report for the Smog Check Inspection, the DMV vehicle registration 18 19 document, the Certificate of Compliance-Brake Adjustment certificate, and the Certificate of Compliance-Lamp Adjustment certificate indicating that the license of Fernando Zuniga was used 20 to perform the brake and lamp certifications. The undercover operator then left the facility and 21 transferred custody of the vehicle to a Bureau representative. 22

36. A Bureau representative later reinspected the vehicle. The defective right front brake
rotor (which was machined below the minimum discard thickness level) remained on the vehicle.
The condition of the right front brake rotor would prevent the Camry from complying with the
requirements of the laws and regulations for issuance of a Certificate of Compliance-Brake
Adjustment for the brake system. The condition of the misaimed headlamp prevented the Camry
from complying with the requirements of the laws and regulations for issuance of a Certificate of a Certificate of

Therefore, no Certificate of Compliance-1 Brake Adjustment or Certificate of Compliance-Lamp Adjustment should have been issued. 2 SIXTH CAUSE FOR DISCIPLINE – 905 SMOG & AUTO REPAIR 3 (Untrue, False or Misleading Statements) 4 Respondent 905 Smog & Auto Repair has subjected its registration and licenses to 37. 5 disciplinary action under Code section 9884.7(a)(1), and California Code of Regulations, title 16, 6 section 3371, in that it invoiced and charged for inspecting the entire brake system and lamp 7 system and issued Certificates of Compliance stating the brake and lamp systems were in 8 compliance, when in fact the vehicle should have failed the inspection. The front disc brake 9 rotors were certified as above the manufacturer service limits, when in fact the right front brake 10 rotor was below the minimum discard thickness. The headlamps were certified as not in need of 11 12 adjustment, when in fact the right front headlamp was misadjusted. **SEVENTH CAUSE FOR DISCIPLINE – 905 SMOG & AUTO REPAIR** 13 14 (Fraud) 38. Respondent 905 Smog & Auto Repair has subjected its registration and licenses to 15 disciplinary action under Code section 9884.7(a)(4) in that it misrepresented to the undercover 16 operator that 905 Smog & Auto Repair inspected the brake and lamp systems on the vehicle and 17 they were in passable condition. 905 Smog & Auto Repair knew that the brake and lamp systems 18 19 had not been properly inspected and they intended the undercover operator to rely on these misrepresentations; and 905 Smog & Auto Repair charged for the service and accepted payment. 20 21 EIGHTH CAUSE FOR DISCIPLINE – 905 SMOG & AUTO REPAIR (Certificates Issued to Nonconforming Vehicle) 22 39. Respondent 905 Smog & Auto Repair has subjected its registration and licenses to 23 disciplinary action under Code section 9889.16 in that upon an inspection or after an adjustment 24 purportedly made in conformity with the instructions of the Bureau, 905 Smog & Auto Repair 25 issued Certificates of Compliance for a brake adjustment and lamp adjustment to a non-26 conforming vehicle in violation of California Code of Regulations, Title 16, 3316, subdivision 27 (d)(2), and California Code of Regulations, title 16, section 3321, subdivision (c)(2). 28 10(MICAR INTERNATIONAL, INC. DBA 905 SMOG & AUTO REPAIR; FERNANDO ZUNIGA)

TENTH CAUSE FOR DISCIPLINE – FERNANDO ZUNIGA

(False or Misleading Certificate)

Respondent Fernando Zuniga's licenses are subject to disciplinary action under Code section 9889.22 in that his licenses were used to inspect and certify the brake and lamp systems on the Toyota Camry. The certificates of compliance withheld or inserted information which would cause the document to be false or mislcading, indicating it was compliant when in fact it 14 was not, in violation of California Code of Regulations, Title 16, section 3373.

OTHER MATTERS

42. Under Code section 9884.7, subdivision (c), the Director may invalidate temporarily 17 or permanently or refuse to validate, the registrations for all places of business operated in this 18 19 state by an automotive repair dealer upon a finding that the automotive repair dealer has engaged in a course of repeated and willful violations of the laws and regulations pertaining to an 20 21 automotive repair dealer.

Under Code section 9889.9, if Lamp Station License Number LS 240846 and Brake 43. 22 Station License Number BS 240846 is revoked or suspended following a hearing under Article 7 23 of the Automotive Repair Act, any additional license issued under Articles 5 and 6 in the name of 24 Miguel Angel Carranza, may be likewise revoked or suspended. 25
