25	1. On or about January 16, 2024, Complainant Patrick Dorais ("Complainant"), in his			
26	official capacity as the Chief of the Bureau of Automotive Repair ("Bureau"), Department of			
27	Consumer Affairs, filed Accusation No. 79/23-6468 against Victor Manuel Murillo dba Primos			
28	Smog ("Respondent Primos Smog") and Vinnie Huynh ("Respondent Huynh") before the

8	No. 79/23-6468 and will expire on September 30, 2024, however was suspended.			
9	Smog Check, Test Only, Station License			
10	3. On or about October 31, 2018, the Bureau issued Smog Check, Test Only Station			
11	License Number TC 292140 to Respondent Primos Smog. The Smog Check, Test Only Station			
12	License was in full force and effect at all times relevant to the charges brought in Accusation No.			
13	79/23-6468 and will expire on September 30, 2024, however was suspended.			
14	STAR Station Certification			
15	4. On or about August 9, 2019, the Bureau certified Primos Smog as a STAR Station			
16	and the certification was suspended on May 26, 2023. The STAR Station Certification is no			
17	longer suspended. The STAR Station Certification was reinstated on September 14, 2023

19	Smog Check Inspector License			
20	5. On or about July 2, 2021, the Bureau issued Smog Check Inspector License Number			
21	EO 643169 to Respondent Huynh. The Smog Check Inspector License was in full force and			
22	effect at all times relevant to the charges brought in Accusation No. 79/23-6468 and will expire			
23	on February 28, 2025, however was suspended.

27	6. On or about June 30, 2014, the Bureau issued Automotive Repair Dealer Registration			
28	Number ARD 277112 to Vicente Paul Guerrero dba Guerrero Auto ("Guerrero Auto"). The			

- 13. The Bureau takes official notice of its records and the fact that Respondent Primos Smog failed to file a Notice of Defense within 15 days after service upon him of the Accusation, and therefore waived his right to a hearing on the merits of Accusation No. 79/23-6468.
- 14. The Bureau takes official notice of its records and the fact that Respondent Huynh failed to file a Notice of Defense within 15 days after service upon him of the Accusation, and therefore waived his right to a hearing on the merits of Accusation No. 79/23-6468.
 - 15. California Government Code section 11520(a) states, in pertinent part:
 - (a) If the respondent either fails to file a notice of defense . . . or to appear at the hearing, the agency may take action based upon the respondent's express admissions or upon other evidence and affidavits may be used as evidence without any notice to respondent
- 16. Pursuant to its authority under Government Code section 11520, the Director after having reviewed the proof of service dated January 17, 2024, signed by Alfred Palma finds Respondents Primos Smog and Huynh are in default. The Director will take action without further hearing and, based on the relevant evidence contained in the Default Decision Investigatory Evidence Packet in this matter, finds that the charges and allegations in Accusation No. 79/23-6468, are separately and severally, found to be true and correct by clear and convincing evidence.

DETERMINATION OF ISSUES

- Based on the foregoing findings of fact, Respondents Victor Manuel Murillo dba
 Primos Smog and Vinnie Huynh have subjected their Automotive Repair Dealer Registration No.
 ARD 292140, Smog Check, Test Only Station License No. TC 292140 and Smog Check
 Inspector License No. EO 643169 to discipline.
 - 2. The agency has jurisdiction to adjudicate this case by default.
- 3. The Director of the Department of Consumer Affairs is authorized to revoke Respondents' Automotive Repair Dealer Registration, Smog Check, Test Only Station and Smog Check Inspector License based upon the following violations alleged in the Accusation which are supported by the evidence contained in the Default Decision Investigatory Evidence Packet in this case:

7	Pursuant to Government Code section 11520, subdivision (c), Respondents Primos Smog				
8	and Huynh may serve a written motion requesting that the Decision be vacated and stating the				
9	grounds relied on within seven (7) days after service of the Decision on Respondents. The				
10	motion should be sent to the Bureau of Automotive Repair, ATTN: Patrick Lutfi, 10949 North				
11	Mather Boulevard, Rancho Cordova, CA 95670. The agency in its discretion may vacate the				
12	Decision and grant a hearing on a showing of good cause, as defined in the statute.				
13	This Decision shall become effective on <u>April 24, 2024</u> .
