ORDER GRANTING SURRENDER OF LICENSE

The Decision in the above-captioned matter was adopted by the Director of the Department of Consumer Affairs (Director) on December 23, 2025, effective January 29, 2026. Pursuant to the Decision, Automotive Repair Dealer Registration No. ARD 302939 and Smog Check Test Only Station License No. TC 302939 issued to Erik A. Sanchez, dba Exotic Smog, as well as any additional licenses issued to Erik A. Sanchez under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code were revoked. The revocations were stayed, and the registration and licenses were placed on probation for five years with terms and conditions. On or about February 5, 2026, the Director received Respondent's documented request seeking the stay of revocation for Automotive Repair Dealer Registration No. ARD 302939 and Smog Check Test Only Station License No. TC 302939 as well as Respondent's Smog Check Inspector License No. EO 644998 to be vacated pursuant to Term and Condition 11 of the Decision.

Pursuant to the Term and Condition 11, the Director HEREBY VACATES the stay order and carries out the disciplinary order of revocation for ARD 302939, Smog Check Test Only Station License No. TC 302939, and Smog Check Inspector License No. EO 644998 only. All other licenses subject to the Decision shall remain in effect.
