PARTIES

1. Patrick Dorais (Complainant) brings this Accusation solely in his official capacity as the Chief of the Bureau of Automotive Repair, Department of Consumer Affairs.

2. In or about 1999, the Bureau of Automotive Repair issued Automotive Repair Dealer Registration Number ARD 203264 to Edgar Regalado, owner, T&R Automotive Repair; (Respondent). The Automotive Repair Dealer Registration was in full force and effect at all times relevant to the charges brought herein and will expire on January 31, 2022, unless renewed.

3. On or about March 11, 1999, the Bureau of Automotive Repair issued Smog Check Station License Number RC 203264 to Edgar Regalado, owner, T&R Automotive Repair; (Respondent). The Smog Check Station License was in full force and effect at all times relevant to the charges brought herein and will expire on January 31, 2022, unless renewed.

4. On or about February 17, 2017, the Bureau of Automotive Repair issued a STAR Station Certification to T&R Automotive Repair.

5. On or about August 22, 2013, the Bureau of Automotive Repair issued Smog Check Inspector License Number EO 315180 to Edgar Rolando Regalado; (Regalado). The Smog Check Inspector License was in full force and effect at all times relevant to the charges brought herein and will expire on September 30, 2021, unless renewed.

6. On or about August 22, 2013, the Bureau of Automotive Repair issued Smog Check Repair Technician License Number EI 315180 to Edgar Rolando Regalado. The Smog Check Repair Technician License was in full force and effect at all times relevant to the charges brought herein and will expire on September 30, 2021, unless renewed.

7. On or about January 27, 2017, the Bureau of Automotive Repair issued Smog Check Inspector License Number EO 639995 to Rolando Edgar Regalado Turcios (Turcios). The Smog Check Inspector License will expire on October 31, 2022, unless renewed.

JURISDICTION

8. This Accusation is brought before the Director of the Department of Consumer Affairs ("Director") for the Bureau, under the authority of the following laws.

///

9. Section 9884.7 of the Business and Professions Code¹ provides that the Director may revoke an ARD registration.

10. Section 9884.13 of the Code provides, in pertinent part, that the expiration of a valid registration shall not deprive the director or chief of jurisdiction to proceed with a disciplinary proceeding against an automotive repair dealer or to render a decision invalidating a registration temporarily or permanently.

STATUTORY PROVISIONS

11. Section 9884.7 of the Code states:

(a) The director, where the automotive repair dealer cannot show there was a bona fide error, may deny, suspend, revoke, or place on probation the registration of an automotive repair dealer for any of the following acts or omissions related to the conduct of the business of the automotive repair dealer, which are done by the automotive repair dealer or any automotive technician, employee, partner, officer, or member of the automotive repair dealer.

(1) Making or authorizing in any manner or by any means whatever any statement written or oral which is untrue or misleading, and which is known, or which by the exercise of reasonable care should be known, to be untrue or misleading.

• • •

(4) Any other conduct which constitutes fraud.

• • •

(6) Failure in any material respect to comply with the provisions of this chapter or regulations adopted pursuant to it.

12. Section 44072.2 of the Health and Safety Code states:

The director may suspend, revoke, or take other disciplinary action against a license as provided in this article if the licensee, or any partner, officer, or director thereof, does any of the following:

(a) Violates any section of this chapter [the Motor Vehicle Inspection Program (Health and Saf. Code, ' 44000, et seq.)] and the regulations adopted pursuant to it, which related to the licensed activities. . . .

(c) Violates any of the regulations adopted by the director pursuant to this chapter.

¹ All statutory references herein shall be to the Business and Professions Code unless specifically stated otherwise.

1 (d) Commits any act involving dishonesty, fraud, or deceit whereby another is
2 injured. . . .

3 13. Section 44072.10 of the Health and Safety Code states, in pertinent part:

4 . . .

5 (c) The department shall revoke the license of any smog check technician or
6 station license who fraudulently certifies vehicles or participates in the fraudulent
7 inspection of vehicles. A fraudulent inspection includes, but is not limited to, all of
8 the following:

8 . . .

9 (2) Tampering with a vehicle emission control system or test analyzer system.

10 (3) Tampering with a vehicle in a manner that would cause the vehicle to
11 falsely pass or falsely fail an inspection.

12 (4) Intentional or willful violation of this chapter or any regulation, standard, or
13 procedure of the department implementing this chapter.

13 **REGULATORY PROVISIONS**

14 14. California Code of Regulations, title 16, section 3340.24, subdivision (c), states:

15 The bureau may suspend or revoke the license of or pursue other legal action
16 against a licensee, if the licensee falsely or fraudulently issues or obtains a certificate
17 of compliance or a certificate of noncompliance.

18 15. California Code of Regulations, title 16, section 3340.30, states:

19 A smog check technician shall comply with the following requirements at all
20 times while licensed.

21 (a) A licensed technician shall inspect, test and repair vehicles in accordance
22 with section 44012 of the Health and Safety Code, section 44035 of the Health and
23 Safety Code, and section 3340.42 of this article. . . .”

24 16. California Code of Regulations, title 16, section 3340.35, states, in pertinent part:

25

26 (c) A licensed station shall issue a certificate of compliance or noncompliance
27 to the owner or operator of any vehicle that has been inspected in accordance with the
28 procedures specified in section 3340.42 of this article and has all the required
emission control equipment and devices installed and functioning correctly. . . .

17 17. California Code of Regulations, title 16, section 3340.42, sets forth specific emissions
18 test methods and procedures which apply to all vehicles inspected in the State of California.

1 21. If the vehicle passes the visual, functional and tailpipe tests, it passes the overall
2 inspection and a Certificate of Compliance is issued and transmitted electronically to the Vehicle
3 Information Database (“VID”). These Certificates of Compliance are purchased in blocks of fifty
4 (50) through the EIS or OIS from the VID, using a pre-arranged electronic bank account debit
5 system or by check, via mail, from Bureau Headquarters in Sacramento. Each Certificate of
6 Compliance has a unique control number so that it can be tracked to determine which Smog
7 Check Station purchased the Certificate of Compliance and to which vehicle it was issued.

8 22. The VID contains registration data from Department of Motor Vehicles (“DMV”)
9 plus emission standards, vehicle smog check inspections, smog check stations and technicians,
10 and Certificates of Compliance. The VID receives the passing smog check results immediately
11 following the inspection. During the vehicle registration process, the DMV accesses the VID to
12 verify that the vehicle has been tested and certified. The Bureau can also access the VID to view
13 test data on smog check inspections performed at any Smog Check Station, or search for, retrieve,
14 and print a test record for a particular vehicle which has been tested. The EIS or OIS, depending
15 on the test type, also prints a Vehicle Inspection Report (“VIR”), which is a physical record of the
16 test results and shows the Certificate of Compliance number that was issued if the vehicle passed
17 the smog inspection.

18 23. The smog check technician must sign the VIR under penalty of perjury to indicate
19 that the inspection was done within Bureau guidelines. Smog Check Stations are required by law
20 to maintain a copy of the VIR along with a copy of the repair invoice for three years. The
21 consumer’s VIR serves as a receipt and proof that the VID was updated and a Certificate of
22 Compliance was issued. Licensed Smog Check Technicians are the only persons authorized by
23 the Bureau to perform official inspections. They are issued a personal access code and a license,
24 which are used to gain access to the EIS and OIS to perform smog check inspections.
25 Unauthorized use of another technician’s access code or license is prohibited.

26 24. Respondents have engaged in numerous acts or omissions constituting violations of
27 the Automotive Repair Act (Business and Professions Code section 9880 *et seq.*) and Motor
28 Vehicle Inspection Program (Health and Safety Code section 44000 *et seq.*) through their practice

of “clean plugging.”² The OIS Test Data available on the State database indicated that Respondent Edgar Regalado, owner, T&R Automotive Repair is involved in fraudulent smog inspection activities. A Bureau representative initiated an investigation based on information transmitted to the VID for smog check inspections performed by Respondent Edgar Regalado, owner, T&R Automotive Repair and Respondent Turcios. The investigation revealed that the data related to certain vehicles certified by Respondent Edgar Regalado, owner, T&R Automotive Repair contained a pattern of unmistakable discrepancies between the information transmitted during the inspections and documented information known about the vehicles at issue. Specifically, the representative compared the data received from the certified vehicles to data from vehicles of the same year, make, and model and determined that the data from at least thirteen (13) of the certified vehicles contained two or more of the following unmistakable discrepancies: (1) incorrect eVINs; (2) incorrect vehicle communication protocols; and (3) incorrect PID counts. These documented discrepancies confirm that the vehicles receiving smog certificates from Respondent Edgar Regalado, owner, T&R Automotive Repair were fraudulently tested during the smog inspection using the “clean plugging” method. The following chart (“Table 1”) illustrates the documented clean plugging activities of Respondents between May 15, 2019 and September 8, 2020.

25. The above chart of Respondents' smog check activities between May 15, 2019, and September 8, 2020, shows that Respondents participated in a scheme to perform at least thirteen (13) fraudulent Smog Check inspections resulting in the issuance of thirteen (13) fraudulent electronic Smog Check Certificates of Compliance.

FIRST CAUSE FOR DISCIPLINE

(Untrue or Misleading Statements - Respondent Edgar Regalado owner, T&R Automotive Repair)

26. Respondent Edgar Regalado owner, T&R Automotive Repair's registration is subject to disciplinary action pursuant to section 9884.7, subdivision (a)(1), in that between May 15,

2019 and September 8, 2020, Respondent Edgar Regalado owner, T&R Automotive Repair; made or authorized statements which he knew or in the exercise of reasonable care should have known to be untrue or misleading, as follows: Respondent Edgar Regalado owner, T&R Automotive Repair; certified that the vehicles set forth above in Table 1, had passed inspection and were in compliance with applicable laws and regulations. In fact, Respondent Edgar Regalado owner, T&R Automotive Repair; conducted the inspections on those vehicles using the clean plugging method in order to issue smog certificates of compliance, and did not test or inspect the vehicles as required by Health and Safety Code section 44012.

SECOND CAUSE FOR DISCIPLINE

(Fraud - Respondent Edgar Regalado owner, T&R Automotive Repair)

27. Respondent Edgar Regalado owner, T&R Automotive Repair's registration is subject to disciplinary action pursuant to section 9884.7, subdivision (a)(4), in that between May 15, 2019 and September 8, 2020, Respondent Edgar Regalado owner, T&R Automotive Repair; committed acts which constitute fraud by issuing electronic certificates of compliance for the vehicles set forth above in Table 1, without performing bona fide inspections of the emission control devices and systems on those vehicles, thereby depriving the People of the State of California of the protection afforded by the Motor Vehicle Inspection Program.

THIRD CAUSE FOR DISCIPLINE

(Failure to Comply with the Motor Vehicle Inspection Program – Respondent Edgar Regalado owner, T&R Automotive Repair.)

28. Respondent Edgar Regalado owner, T&R Automotive Repair's station license is subject to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (a), in that between May 15, 2019 and September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Edgar Regalado owner, T&R Automotive Repair; failed to comply with the following sections of the Health and Safety Code:

(a) **Section 44012:** Respondent Edgar Regalado owner, T&R Automotive Repair failed to ensure that the emission control tests were performed on the vehicles, in accordance with procedures prescribed by the department.

(b) **Section 44015:** Respondent Edgar Regalado owner, T&R Automotive Repair issued electronic certificates of compliance for the vehicles, without ensuring that the vehicles were properly tested and inspected to determine if they were in compliance with Health and Safety Code section 44012.

FOURTH CAUSE FOR DISCIPLINE

(Failure to Comply with Regulations Pursuant to the Motor Vehicle Inspection Program - Respondent Edgar Regalado owner, T&R Automotive Repair)

29. Respondent Edgar Regalado owner, T&R Automotive Repair's station license is subject to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (c), in that between May 15, 2019 and September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Edgar Regalado owner, T&R Automotive Repair failed to comply with the following provisions of the California Code of Regulations, Title 16, as follows:

(a) **Section 3340.35, subdivision (c):** Respondent Edgar Regalado owner, T&R Automotive Repair issued electronic certificates of compliance even though those vehicles had not been inspected in accordance with section 3340.42, Title 16, of the California Code of Regulations.

(b) **Section 3340.42:** Respondent Edgar Regalado owner, T&R Automotive Repair failed to conduct the required smog tests and inspections on those vehicles in accordance with the Bureau's specifications.

FIFTH CAUSE FOR DISCIPLINE

(Dishonesty, Fraud or Deceit - Respondent Edgar Regalado owner, T&R Automotive Repair)

30. Respondent Edgar Regalado owner, T&R Automotive Repair's station license is subject to disciplinary action pursuant to Health and Safety Code section 44072.2, subdivision (d), in that between May 15, 2019 and September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Edgar Regalado owner, T&R Automotive Repair committed acts involving dishonesty, fraud or deceit whereby another was injured by issuing electronic certificates of compliance for those vehicles without performing bona fide inspections of the

1 emission control devices and systems on the vehicles., thereby depriving the People of the State
2 of California of the protection afforded by the Motor Vehicle Inspection Program.

3 **SIXTH CAUSE FOR DISCIPLINE**

4 **(Violations of the Motor Vehicle Inspection Program – Respondent Turcios)**

5 31. Respondent Turcios’s smog check inspector license is subject to discipline pursuant
6 to Health and Safety Code section 44072.2, subdivision (a), in that between May 15, 2019 and
7 September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Turcios failed
8 to comply with section 44012 of the Health and Safety Code in a material respect, as follows:
9 Respondent Turcios failed to perform the emission control tests on those vehicles in accordance
10 with procedures prescribed by the department.

11 **SEVENTH CAUSE FOR DISCIPLINE**

12 **(Failure to Comply with Regulations Pursuant to the Motor Vehicle Inspection Program –**
13 **Respondent Turcios)**

14 32. Respondent Turcios’s smog check inspector license is subject to discipline pursuant
15 to Health and Safety Code section 44072.2, subdivision (c), in that between May 15, 2019 and
16 September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Turcios failed
17 to comply with provisions of the California Code of Regulations, title 16, as follows:

18 (a) **Section 3340.30, subdivision (a):** Respondent Turcios failed to inspect and test those
19 vehicles in accordance with Health and Safety Code section 44012.

20 (b) **Section 3340.42:** Respondent Turcios failed to conduct the required smog tests and
21 inspections on those vehicles in accordance with the Bureau’s specifications.

22 **EIGHTH CAUSE FOR DISCIPLINE**

23 **(Dishonesty, Fraud or Deceit - Respondent Turcios)**

24 33. Respondent Turcios’s smog check inspector license is subject to discipline pursuant
25 to Health and Safety Code section 44072.2, subdivision (d), in that between May 15, 2019 and
26 September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Turcios
27 committed acts involving dishonesty, fraud or deceit whereby another was injured by issuing
28 electronic certificates of compliance for those vehicles without performing bona fide inspections

of the emission control devices and systems on the vehicles, thereby depriving the People of the State of California of the protection afforded by the Motor Vehicle Inspection Program.

NINTH CAUSE FOR DISCIPLINE

(Violations of the Motor Vehicle Inspection Program – Respondent Regalado)

34. Respondent Regalado’s smog check inspector license and smog check repair technician licenses are subject to discipline pursuant to Health and Safety Code section 44072.2, subdivision (a), in that between May 15, 2019 and September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Regalado failed to comply with section 44012 of the Health and Safety Code in a material respect, as follows: Respondent Regalado failed to perform the emission control tests on those vehicles in accordance with procedures prescribed by the department.

TENTH CAUSE FOR DISCIPLINE

(Failure to Comply with Regulations Pursuant to the Motor Vehicle Inspection Program – Respondent Regalado)

35. Respondent Regalado’s smog check inspector license and smog check repair technician licenses are subject to discipline pursuant to Health and Safety Code section 44072.2, subdivision (c), in that between May 15, 2019 and September 8, 2020, regarding the vehicles set forth above in Table 1, Respondent Regalado failed to comply with provisions of the California Code of Regulations, title 16, as follows:

(a) **Section 3340.30, subdivision (a):** Respondent Regalado failed to inspect and test those vehicles in accordance with Health and Safety Code section 44012.

(b) **Section 3340.42:** Respondent Regalado failed to conduct the required smog tests and inspections on those vehicles in accordance with the Bureau’s specifications.

ELEVENTH CAUSE FOR DISCIPLINE

(Dishonesty, Fraud or Deceit - Respondent Regalado)

36. Respondent Regalado’s smog check inspector license and smog check repair technician licenses are subject to discipline pursuant to Health and Safety Code section 44072.2, subdivision (d), in that between May 15, 2019 and September 8, 2020, regarding the vehicles set

1 forth above in Table 1, Respondent Regalado committed acts involving dishonesty, fraud or
2 deceit whereby another was injured by issuing electronic certificates of compliance for those
3 vehicles without performing bona fide inspections of the emission control devices and systems on
4 the vehicles., thereby depriving the People of the State of California of the protection afforded by
5 the Motor Vehicle Inspection Program.

6 **OTHER MATTERS**

7 37. Pursuant to Business & Professions Code section 9884.7, subdivision (c), the Director
8 may suspend, revoke, or place on probation the registration for all places of business operated in
9 this State by Respondent Edgar Regalado owner, T&R Automotive Repair upon a finding that
10 Respondent Edgar Regalado owner, T&R Automotive Repair has, or is, engaged in a course of
11 repeated and willful violations of the laws and regulations pertaining to an automotive repair
12 dealer.

13 38. Pursuant to Health & Safety Code section 44072.8, if Smog Check Station License
14 Number RC 203264 issued to Respondent Edgar Regalado owner, T&R Automotive Repair is
15 revoked or suspended following a hearing under this article, any additional license issued under
16 Chapter 5, Part 5, Division 26 in the name of said licensee may be likewise revoked or suspended
17 by the Director.

18 39. Pursuant to Health & Safety Code section 44072.8, if Smog Check Inspector License
19 Number EO 315180 issued to Respondent Regalado is revoked or suspended following a hearing
20 under this article, any additional license issued under Chapter 5, Part 5, Division 26 in the name
21 of said licensee may be likewise revoked or suspended by the Director.

22 40. Pursuant to Health & Safety Code section 44072.8, if Smog Check Repair Technician
23 License Number EI 315180 issued to Respondent Regalado is revoked or suspended following a
24 hearing under this article, any additional license issued under Chapter 5, Part 5, Division 26 in the
25 name of said licensee may be likewise revoked or suspended by the Director.

26 41. Pursuant to Health & Safety Code section 44072.8, if Smog Check Inspector License
27 Number EO 639995 issued to Respondent Turcios is revoked or suspended following a hearing
28

1 under this article, any additional license issued under Chapter 5, Part 5, Division 26 in the name
2 of said licensee may be likewise revoked or suspended by the Director.

3 **PRAYER**

4 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
5 and that following the hearing, the Director of Consumer Affairs issue a decision:

6 1. Revoking or suspending Automotive Repair Dealer Registration Number ARD
7 203264, issued to Respondent Edgar Regalado owner, T&R Automotive Repair;

8 2. Revoking or suspending any other Automotive Repair Dealer registration license
