ACCUSATION

#### **PARTIES**

- 1. Patrick Dorais (Complainant) brings this Accusation solely in his official capacity as the Chief of the Bureau of Automotive Repair (Bureau), Department of Consumer Affairs.
- 2. On or about December 4, 2018, the Bureau of Automotive Repair issued Automotive Repair Dealer Registration Number ARD 292760 to ONKO Investments, LLC dba Star Smog Depot (Respondent ONKO). Harun Ongun (Respondent Ongun) is a member of Respondent ONKO. The Automotive Repair Dealer Registration was in full force and effect at all times relevant to the charges brought herein and will expire on December 31, 2025, unless renewed.
- 3. On or about December 12, 2018, the Bureau issued Smog Check, Test-Only, Station License Number TC 292760 to Respondent ONKO. The Smog Check, Test-Only, Station License was in full force and effect at all times relevant to the charges brought herein and will expire on December 31, 2025, unless renewed.
- 4. On or about January 24, 2019, Respondent ONKO's Smog Check Station License was certified as STAR Station. The certification will remain active unless the ARD registration and/or Smog Check station license is revoked, cancelled, licenses become delinquent, or certification is suspended.
- 5. In 2005, the Bureau issued Advanced Emission Specialist Technician License
  Number EA 150910 to Respondent Ongun. Respondent Ongun's advanced emission specialist
  technician license was cancelled on August 15, 2012. Pursuant to California Code of
  Regulations, title 16, section 3340.28, subdivision (e), the license was renewed, pursuant to
  Respondent Ongun's election, as Smog Check Inspector License Number EO 150910 and Smog
  Check Repair Technician License Number EI 150910, effective August 15, 2012. The Smog
  Check Inspector License will expire on September 30, 2026, unless renewed. The Smog Check
  Repair Technician License expired on September 30, 2014, and has not been renewed.

6. On or about May 30, 2022, the Bureau issued Smog Check Inspector License Number EO 643702 to Juan Miguel Sebastian Moreno (Respondent Moreno). The Smog Check Inspector License was in full force and effect at all times relevant to the charges brought herein and will expire on June 30, 2026, unless renewed.

#### **JURISDICTION**

- 7. This Accusation is brought before the Director of the Department of Consumer Affairs (Director) for the Bureau, under the authority of the following laws.
- 8. Section 118, subdivision (b), of the Code provides that the suspension, expiration, surrender, and/or cancellation of a license shall not deprive the Director of jurisdiction to proceed with a disciplinary action during the period within which the license may be renewed, restored, reissued or reinstated.
- 9. Section 9884.13 of the Code provides, in pertinent part, that the expiration of a valid registration shall not deprive the director or chief of jurisdiction to proceed with a disciplinary proceeding against an automotive repair dealer or to render a decision invalidating a registration temporarily or permanently.
- 10. Section 44002 of the Health and Safety Code provides, in pertinent part, that the Director has all the powers and authority granted under the Automotive Repair Act for enforcing the Motor Vehicle Inspection Program.
- 11. Section 44072.6 of the Health and Safety Code provides, in pertinent part, that the expiration or suspension of a license by operation of law, or by order or decision of the Director of Consumer Affairs, or a court of law, or the voluntary surrender of the license shall not deprive the Director of jurisdiction to proceed with any investigation of, or action or disciplinary proceedings against the licensee, or to render a decision suspending or revoking the license.

#### **STATUTORY PROVISIONS**

- 12. Section 9884.7 of the Code states:
- (a) The director, if the automotive repair dealer cannot show there was a bona fide error, may deny, suspend, revoke, or place on probation the registration of an automotive repair dealer for any of the following acts or omissions related to the conduct of the business of the automotive repair dealer, which are done by the automotive repair dealer or any automotive technician, employee, partner, officer, or

1	member of the automotive repair dealer:
2	(1) Making or authorizing in any manner or by any means whatever any statement written or oral which is untrue or misleading, and which is known, or which
3	by the exercise of reasonable care should be known, to be untrue or misleading.

7	(6) Failure in any material respect to comply with the provisions of this chapter or regulations adopted pursuant to it.

21	24. Section 125.3 of the Code provides, in pertinent part, that the Board may request the
22	administrative law judge to direct a licensee found to have committed a violation or violations of
23	the licensing act to pay a sum not to exceed the reasonable costs of the investigation and
24	enforcement of the case, with failure of the licensee to comply subjecting the license to not being
25	renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be
26	included in a stipulated settlement.

#### SMOG PROGRAM AND CLEAN PLUGGING ALLEGATIONS

- 25. California's Smog Check Program requires the owners of most motor vehicles in California to take and pass a Smog Check inspection and receive a Certificate of Compliance every two years when renewing their registration and also when the vehicle's title is transferred. These inspections are performed by Smog Check Inspectors at Smog Check Stations, both of which are licensed by BAR.
- 26. The Smog Check inspection in certain Enhanced areas of the State is an Acceleration Simulation Mode (ASM) test performed using an Emission Inspection System (EIS), also known as a BAR 97. This is a computer based five-gas analyzer that measures Hydrocarbons, Carbon Monoxide, Oxides of Nitrogen, Carbon Dioxide, and Oxygen. The inspection involves a test of the vehicle's tailpipe emissions on a dynamometer. In Basic areas of the State, or depending on a vehicle's configuration (all-wheel drive, traction control issue), a similar test called a Two Speed Idle (TSI) test is performed, but instead of applying a load to the vehicle's drive wheels with a dynamometer, the EIS measures the emissions at idle as well as 2500 revolutions per minute (RPM).
- 27. The inspector also performs visual and functional tests on the vehicle as outlined in the Smog Check Manual. The visual inspection of the emission control components verifies the required emission control devices are present and properly connected. Functional tests are also performed which, depending on the vehicle, may include checking the ignition timing, malfunction indicator light (MIL), Exhaust Gas Recirculation (EGR) system, a low-pressure test of the evaporative emissions controls (LPFET), a visible smoke test, and a pressure test of the gas cap.
- 28. On March 9, 2015, BAR implemented a statewide regulatory change requiring the use of the On-Board Diagnostic Inspection System (BAR-OIS) instead of the EIS for the smog testing of 2000 model year and newer gas powered and 1998 and newer diesel vehicles. Most older vehicles require the ASM or TSI test on the EIS. Gas powered vehicles with a gross vehicle weight rating over 14,000 pounds require an inspection on the EIS.

- 29. The newer BAR-OIS smog inspection uses a Data Acquisition Device (DAD), a computer, a bar code scanner, and printer. The DAD is a scan tool that retrieves data from a vehicle's On-Board Diagnostic-generation II (OBD II) computer. The DAD connects the BAR OIS computer to the vehicle's diagnostic link connector (DLC) to retrieve the data from the vehicle. The bar code scanner is used to input technician information, the vehicle identification number (VIN), and DMV renewal information. The printer is used to print Vehicle Inspection Reports.
- 30. Data retrieved and recorded during a BAR-OIS smog check includes: the eVIN, which is the digitally stored VIN programmed into the vehicle's Powertrain Control Module (PCM); the communication protocol, which is the manufacturer/vehicle's specific "language" the PCM uses to relay information; and the number of Parameter Identifications (PIDs), which is the number of specific data values each PCM uses related to emissions controls.
- 31. As part of the BAR-OIS smog inspections, the technician also performs a visual and functional test on the vehicle being inspected. The visual inspection of the emission control components verifies the required emission control devices are present and properly connected and a functional test is performed of the malfunction indicator light (MIL). The BAR-OIS software makes the determination whether or not the vehicle passes the inspection based on the results of the OBD, visual and functional tests. If the vehicle passes the inspection a certificate of compliance is issued. The information from the smog inspection is then transmitted to the Vehicle Information Data (VID).
- 32. BAR can access the VID to view test data on smog check inspections performed at any Smog Check Station, or search for, retrieve, and print a test record for a particular vehicle which has been tested.
- 33. BAR has become aware of methods some Smog Check stations and Smog Check inspectors use to issue smog certificates to vehicles that will not pass a Smog Check test on their own, or in some instances, are not even present during the time the test is performed.
- 34. One method is known as "clean plugging." "Clean plugging" is the act of using one vehicle's properly functioning OBD II system, or another source such as an electronic defeat

device, to generate passing data readings or diagnostic information for the purpose of issuing a smog certificate of compliance to a vehicle that is not in smog compliance and/or not being tested. The vehicle being certified is not the one being tested.

- 35. On or about March 28, 2025, the BAR initiated an investigation of Respondent ONKO's smog check station Star Smog Depot. The investigation revealed Ongun performed two smog inspections at Star Smog Depot using clean-plugging methods. The investigation revealed Respondent Moreno performed eight smog inspections at Star Smog Depot using clean-plugging methods. Respondent ONKO issued 10 certificates of compliance to the clean plugged vehicles.
- 36. A Bureau representative reviewed data for the clean-plugged vehicles inspected by Respondents. The data revealed that the ten vehicles that were purportedly tested by Respondents were not and could not have been connected to the DAD when they were being certified because the OBD-II data purportedly transmitted by those vehicles could not have been transmitted by those vehicles.
- 37. Respondents clean plugged and issued certificates of compliance to the following vehicles:

#### FIRST CAUSE FOR DISCIPLINE

#### (Untrue or Misleading Statements - Registration)

38. Respondent ONKO has subjected its Automotive Repair Dealer Registration to discipline under Code section 9884.7, subdivision (a)(1), in that Respondent ONKO made statements which it knew or which by exercise of reasonable care should have known were untrue or misleading, as set forth above in the Smog Program and Clean Plugging Allegations. Respondent ONKO purported to test vehicles, and certified that the vehicles passed inspection and were in compliance with applicable laws and regulations. In fact, Respondent conducted the inspections on those vehicles using clean-plugging methods.

#### SECOND CAUSE FOR DISCIPLINE

#### (Fraud - Registration)

39. Respondent ONKO has subjected its Automotive Repair Dealer Registration to discipline under Code section 9884.7, subdivision (a)(4), in that it committed acts which constitute fraud, as set forth above in the Smog Program and Clean Plugging Allegations.

#### THIRD CAUSE FOR DISCIPLINE

### (False or Misleading Records-Registration)

40. Respondent has ONKO subjected its Automotive Repair Dealer Registration to discipline under Code section 9884.7, subdivision (a)(6), in that it violated California Code of Regulations, title 16, section 3373, by creating and issuing false or misleading certificates of compliance and vehicle inspection reports for the 10 vehicles that were clean plugged as set forth above in the Smog Program and Clean Plugging Allegations. The certificates and inspection reports indicated the vehicles were tested in accordance with all Bureau requirements and the vehicles were qualified to receive certificates of compliance. This was false as the vehicles were clean plugged.

#### FOURTH CAUSE FOR DISCIPLINE

#### (Dishonesty, Fraud or Deceit – Smog Station License)

41. Respondent ONKO has subjected its Smog Check Station License to discipline under Health and Safety Code sections 44072.10 and/or 44072.2, subdivision (d), in that it committed

acts involving dishonesty, fraud or deceit, whereby another was injured by issuing electronic certificates of compliance for vehicles without performing bona fide inspections of the emission control devices and systems on the vehicles, thereby depriving the People of the State of California of the protection afforded by the Motor Vehicle Inspection Program. Respondent ONKO participated in clean-plugging as set forth above in the Smog Program and Clean Plugging Allegations above.

#### FIFTH CAUSE FOR DISCIPLINE

#### (Violation of the Motor Vehicle Inspection Program- Smog Station License)

- 42. Respondent ONKO has subjected its Smog Check Station License to discipline under Health and Safety Code sections 44072.10 and/or 44072.2, subdivisions (a) and (c), in that it violated sections of that Code and applicable regulations, through conduct described in the Smog Program and Clean Plugging Allegations, as follows:
- a. **Section 44012**: Respondent failed to ensure that smog inspections were performed on vehicles in accordance with procedures prescribed by the department.
- b. Section 3340.24, subdivision (c): Respondent falsely or fraudulently issued electronic certificates of compliance to certain vehicles without performing bona fide inspections of the emission control devices and systems on those vehicles.
- c. Section 3340.41, subdivision (c): Respondent entered false information about vehicles being tested into OIS.
- d. **Section 3340.42**: Respondent failed to conduct the required smog tests and inspections on certain vehicles in accordance with the Bureau's specifications.
- e. **Section 3340.45** Respondent violated the procedures contained in the Smog Check Manual by entering vehicle identification information for a vehicle that was not being tested.

#### **SIXTH CAUSE FOR DISCIPLINE**

#### (Dishonesty, Fraud or Deceit – Smog Check Inspector License-Moreno)

43. Respondent Moreno has subjected his Smog Check Inspector and License to discipline under Health and Safety Code sections 44072.10 and/or 44072.2, subdivision (d), in that he committed acts involving dishonesty, fraud or deceit, whereby another was injured by

issuing electronic certificates of compliance for vehicles without performing bona fide inspections of the emission control devices and systems on the vehicles, thereby depriving the People of the State of California of the protection afforded by the Motor Vehicle Inspection Program. Respondent Moreno participated in clean-plugging as set forth above in the Smog Program and Clean Plugging Allegations above.

#### **SEVENTH CAUSE FOR DISCIPLINE**

# (Violation of the Motor Vehicle Inspection Program- Smog Check Inspector License Moreno)

- 44. Respondent Moreno has subjected his Smog Check Inspector License to discipline under Health and Safety Code sections 44072.10 and/or 44072.2, subdivisions (a) and (c), in that he violated sections of that Code and applicable regulations, through conduct described in the Smog Program and Clean Plugging Allegations, as follows:
- a. **Section 44012**: Respondent failed to ensure that smog inspections were performed on vehicles in accordance with procedures prescribed by the department.
- b. Section 3340.24, subdivision (c): Respondent falsely or fraudulently issued electronic certificates of compliance to certain vehicles without performing bona fide inspections of the emission control devices and systems on those vehicles.
- c. **Section 3340.30, subdivision (a)**: Respondent failed to inspect the vehicles in accordance with Health and Safety Code section 44012 and California Code of Regulations, title 16, section 3340.42.
- d. Section 3340.41, subdivision (c): Respondent entered false information about vehicles being tested into OIS.
- e. **Section 3340.42**: Respondent failed to conduct the required smog tests and inspections on certain vehicles in accordance with the Bureau's specifications.
- f. **Section 3340.45** Respondent violated the procedures contained in the Smog Check Manual by entering vehicle identification information for a vehicle that was not being tested.
- g. **Section 44059:** Respondent willfully made false statements in issuing the Smog Certificates of compliance and on the Vehicle Inspection Reports.

#### **EIGHTH CAUSE FOR DISCIPLINE**

#### (Dishonesty, Fraud or Deceit - Smog Check Inspector - Ongun)

45. Respondent Ongun has subjected his Smog Check Inspector License to discipline under Health and Safety Code sections 44072.10 and/or 44072.2, subdivision (d), in that he committed acts involving dishonesty, fraud or deceit, whereby another was injured by issuing electronic certificates of compliance for vehicles without performing bona fide inspections of the emission control devices and systems on the vehicles, thereby depriving the People of the State of California of the protection afforded by the Motor Vehicle Inspection Program. Respondent Ongun participated in clean-plugging as set forth above in the Smog Program and Clean Plugging Allegations above.

#### **NINETH CAUSE FOR DISCIPLINE**

# (Violation of the Motor Vehicle Inspection Program- Smog Check Inspector License-Ongun)

- 46. Respondent Ongun has subjected his Smog Check Inspector License to discipline under Health and Safety Code sections 44072.10 and/or 44072.2, subdivisions (a) and (c), in that he violated sections of that Code and applicable regulations, through conduct described in the Smog Program and Clean Plugging Allegations, as follows:
- a. **Section 44012**: Respondent failed to ensure that smog inspections were performed on vehicles in accordance with procedures prescribed by the department.
- b. Section 3340.24, subdivision (c): Respondent falsely or fraudulently issued electronic certificates of compliance to certain vehicles without performing bona fide inspections of the emission control devices and systems on those vehicles.
- c. Section 3340.30, subdivision (a): Respondent failed to inspect the vehicles in accordance with Health and Safety Code section 44012 and California Code of Regulations, title 16, section 3340.42.
- d. **Section 3340.41, subdivision (c)**: Respondent entered false information about vehicles being tested into OIS.

- e. **Section 3340.42**: Respondent failed to conduct the required smog tests and inspections on certain vehicles in accordance with the Bureau's specifications.
- f. Section 3340.45 Respondent violated the procedures contained in the Smog Check Manual by entering vehicle identification information for a vehicle that was not being tested.
- g. **Section 44059:** Respondent willfully made false statements in issuing the Smog Certificates of compliance and on the Vehicle Inspection Reports.

#### **OTHER MATTERS**

- 47. Pursuant to Code section 9884.7, subdivision (c), the Director may suspend, revoke, or place on probation the registration for all places of business operated in this state by Respondent ONKO upon a finding that Respondent has, or is, engaged in a course of repeated and willful violations of the laws and regulations pertaining to an automotive repair dealer.
- 48. Pursuant to Health & Safety Code section 44072.8, if Respondent ONKO's Smog Check Station License is revoked or suspended, any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code in the name of said licensee may be likewise revoked or suspended by the director.
- 49. Pursuant to Health & Safety Code section 44072.8, if Respondent Ongun's Smog Check Inspector License is revoked or suspended, any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code in the name of said licensee may be likewise revoked or suspended by the director.
- 50. Pursuant to Health & Safety Code section 44072.8, if Respondent Moreno's Smog Check Inspector License is revoked or suspended, any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code in the name of said licensee may be likewise revoked or suspended by the director.

#### **DISCIPLINARY CONSIDERATIONS**

51. To determine the degree of discipline, if any, to be imposed on Respondent ONKO and Respondent Ongun and, Complainant alleges that on or about April 19, 2019, the Bureau held a ProActive Conference with Respondent Ongun at Star Smog Depot. Respondent ONKO

and Respondent Ongun were advised to follow all laws and regulations under the Automotive Repair Act and were warned that failure to do so could result in disciplinary action.

#### **PRAYER**

WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged, and that following the hearing, the Director of the Department of Consumer Affairs issue a decision:

- Revoking or suspending Automotive Repair Dealer Registration Number ARD
   292760, issued ONKO Investments, LLC., dba Star Smog Depot;
- 2. Revoking or suspending any additional Automotive Repair Dealer Registration(s) issued to ONKO Investments, LLC;
- 3. Revoking or suspending Smog Check Test Only Station License Number TC 292760, issued ONKO Investments, LLC., dba Star Smog Depot;
- 4. Revoking or suspending any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code to ONKO Investments, LLC;
- 5. Revoking or suspending Smog Check Inspector License Number EO 150910, issued to Harun Ongun;
- 6. Revoking or suspending any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code to Harun Ongun;
- 7. Revoking or suspending Smog Check Inspector License Number EO 643702, issued to Juan Miguel Sebastian Moreno;
- 8. Revoking or suspending any additional license issued under Chapter 5 of Part 5 of Division 26 of the Health and Safety Code to Juan Miguel Sebastian Moreno;
- 9. Ordering ONKO Investments, LLC. to pay the Bureau of Automotive Repair the reasonable costs of the investigation and enforcement of this case, pursuant to Business and Professions Code section 125.3 and if placed on probation, the costs of probation monitoring;
- 10. Ordering Harun Ongun to pay the Bureau of Automotive Repair the reasonable costs of the investigation and enforcement of this case, pursuant to Business and Professions Code section 125.3 and if placed on probation, the costs of probation monitoring;
