In this regular rulemaking action, the Bureau of Automotive Repair ("BAR") seeks to amend regulations applying to automotive repair dealers and mobile automotive repair. An automotive repair dealer now includes those collecting compensation for services referred or sublet. BAR also adopts advertising requirements for all automotive repair businesses.

OAL approves this regulatory action pursuant to section 11349.3 of the Government Code. This regulatory action becomes effective on 10/1/2025.
