# BACKGROUND

- All Automotive Repair Dealers (ARD) are required to post a wall license in an area visible to consumers.
- This wall license contains the ARD's license number, address, expiration date, and the name of the business owner.
- Finding more information about the ARD requires the consumer to navigate the Bureau of Automotive Repair's (BAR) public website, or to call BAR.

# **SYNOPSIS**

- BAR is seeking input on an idea to update each ARD wall license to include a QR code that can be scanned by a mobile device to quickly access additional information about the ARD.
- The QR code would navigate the consumer to an ARD Information page with a link to the disciplinary history for the ARD.

# WALL LICENSE

 The ARD wall license would look similar to the original wall license, but with the addition of a QR code specific to each ARD.

- Here is an example of an ARD Information page:




# DISCIPLINARY HISTORY

 This button would redirect the consumer to the DCA Web License Lookup page which displays an ARD's disciplinary

history.



# FILE A COMPLAINT

- From the ARD Information page, the consumer could also be directed to BAR's existing online complaint submission page.
- The ARD information could be automatically populated into the form fields to increase the accuracy of the complaint submission process.
